SONARWA Life Assurance Company Ltd yajuririye Urukiko Rukuru ivuga ko ubwo Rugina yagirwaga Umuyobozi ukuriye ishami, urwego yariho n'umushahara yahembwaga bitahindutse kandi ko urukiko rwabanje rwamugeneye indishyi nta bimenyetso rushyigiyeho. Avuga ko bitewe n'izo mpinduka, abakozi ba SONARWA S.A bashyizwe muri sosiyete nshya zari zimaze kuvuka, maze ku itariki ya 15/11/2011, ahabwa amasezerano y'igihe kitazwi, agirwa Data Management Officer muri SONARWA Life Assurance Company Ltd, naho ku wa 14/11/2013, agirwa umuyobozi ukuriye ishami rya Huye (Branch Manager), ashingwa no gukurikirana ishami rya Rusizi, amenyeshwa kandi ko umushahara n'urwego ariho bidahindutse, icyakora ko ahawe 200.000 Frw y'ingendo buri kwezi. Rugina Jason yavuze ko we na bagenzi be bazamuwe mu ntera ntibahabwe umushahara ujyanye n'urwego bariho, bandikiye umukoresha bishyuzwa ibirarane by'imishahara, bamenyeshwa ko icyo kibazo kizigwaho, bigeze ku wa 12/04/2017 aho guhabwa igisubizo, basezererwa mu kazi.

[2] Rugina Jason yagejeje icyo kibazo ku mugenzuzi w'umurimo, SONARWA Life Assurance Company Ltd ivuga ko Rugina Jason yasezerewe kubera impamvu z'ubukungu bwatumye ikigo gikora amavugurura mu myanya y'imirimo kandi ko nta mwenda w'imishahara imufitiye. Nyuma yo kutumvikana, Rugina Jason yaregeye Urukiko Rwisumbuye rwa Nyarugenge avuga ko yirukanywe mu kazi mu buryo bunyuranyije n'amategeko, asaba guhabwa amafaranga avuga ko atagenewe mu gihe yari umukozi ndetse akanahabwa indishyi z'ikurikiranarubanza.
