Inavuga ko nta gikorwa kijyanye n’amatora kiraba kugeza ubu ku buryo GREEN PARTY yashingira ku ngingo ya 29 y’Itegeko ryavuzwe haruguru ahubwo ikibazo kiri imbere y’urukiko kikaba ari imyumvire y’ingingo ya 101 na 193 z’Itegeko Nshinga, nyamara Urukiko rukaba ruburanisha ibibazo biriho, aho gusuzuma ibibazo bizavuka, bityo ko icyo Urukiko rushobora gusuzuma ari ibyakorwa mu gihe referendum yaba irimo kuba.

Ishyaka GREEN PARTY ryatanze ikirego muri uru Rukiko risaba ko iyo ngingo ya 101 y'Itegeko Nshinga itahinduka. Iburanisha ry'urubanza ryari ryashyizwe ku itariki ya 8/07/2015, kuri uwo munsu urubanza ntirwaburanishwa bitewe nuko Ishyaka GREEN PARTY ritari rifite avoka uruburanira. Green Party yasabye ko urubanza rusubikwa mu gihe cy'amezi atandatu kugirango ishake avoka uzayiburanira, ariko Urukiko rusanga icyo gihe cyose kidakenewe, iburanisha ryarwo ryimurirwa ku itariki ya 29/07/2015.

Yemeza ko n'ikirego cya GREEN PARTY kiri mu bubasha bw'Urukiko rw'Ikirenga, ko kandi ruramutse rusanze ikirego kitari mu bubasha bw'ari ibyakorwa mu gihe referendum yaba irimo kuba, niba kandi ari inama basaba Urukiko rw'Ikirenga GREEN PARTY yagombye kubikora yisunze ibiteganywa n'ingingo ya 96 y'Itegeko Nshinga, ko rero Urukiko rw'Ikirenga rukwiye kwemeza ko iki kibazo cyakemukira mu zindi nzira.

Ikirego cyatanzwe na GREEN PARTY isaba Urukiko kwemeza ko ingingo ya 101 n'ya 193 z'Itegeko Nshinga zidatanga uburenganzira bwo guhindura manda ya Perezida wa Repubulika, ntaho gihuriye n'imanza zerekeye amatora ya referendumu, bityo n'Urukiko ntirwashingira ku ngingo ya 29(3) ivugwa muri iki gika ngo rwemeze ko rufite ububasha bwo kuburanisha uru rubanza.

[22] Ingingo ya 29(1<sup>o</sup>) y'Itegeko Ngenga N<sup>o</sup>03/2012/0L ryo kuwa 13/06/2012 rigena imiterere, imikorere, n'ububasha by'Urukiko rw'Ikirenga ivuga ko Urukiko rw'Ikirenga rufite ububasha bwo kuburanisha Perezida wa Repubulika kubera kwica Itegeko Nshinga bikomeye kandi nkana. Nk'uko byavuzwe, ikirego muri uru rubanza ni ukwemeza ko ingingo ya 101 n'ya 193 z'Itegeko Nshinga zidatanga uburenganzira bwo guhindura manda ya Perezida wa Repubulika. Iki kirego cyatanzwe na GREEN PARTY kikaba gitandukanye n'ikirego cyashyikirizwa urukiko haregwa Perezida wa Repubulika kwica Itegeko Nshinga. Urukiko rw'Ikirenga rukaba rutashingira ku ngingo ya 29(1) ivugwa muri iki gika, ngo rwemeze ko rufite ububasha bwo kuburanisha ikirego cyatanzwe na GREEN PARTY.

[23] Uruhande rw'abahagarariye Leta, ruvuga ko Urukiko rw'Ikirenga rudafite ububasha bwo gutanga ibisobanuro by'ingingo z'Itegeko Nshinga ko ahubwo, ubwo bubasha bufitwe n'Inteko Ishinga Amategeko aho buteganywa n'ingingo ya 96 y'Itegeko Nshinga ivuga ko "isobanurampamo ry'amategeko rikorwa n'imitwe yombi y'Inteko iteraniye hamwe, Urukiko rw'Ikirenga rumaze kubitangaho inama; buri Mutwe ufata icyemezo ku bwiganze bw'amajwi buvugwa mu ngingo ya 93 y'iri Tegeko Nshinga [.....]".

[24] Ingingo ya 93, igika cya gatatu n'icya kane, y'Itegeko Nshinga igira iti "[...] amategeko asanzwe atorwa ku bwiganze burunduye bw'amajwi y'abagize buri mutwe bitabiriye inama. Amategeko ngenga atorwa ku bwiganze bwa bitatu bya gatanu (3/5) by'abagize buri Mutwe bitabiriye inama ...". Amategeko avugwa mu ngingo ya 93, ni amategeko asanzwe (ordinary laws) n'amategeko ngenga (organic laws). Aya mategeko avugwa mu ngingo ya 93 niyo Inteko Ishinga Amategeko ifitiye ububasha bwo gukorera isobanurampamo. Bityo ibivugwa n'ababuranira Leta muri uru rubanza ko Inteko Ishinga Amategeko ariyo ifite ububasha bwo gukora isobanurampamo, bikaba bifite ishingiro ku mategeko asanzwe n'amategeko ngenga. Ku birebana n'Itegeko Nshinga, akaba nta rwego ruvugwa rwahawe ububasha bwo gutanga ibisobanuro by'ingingo zaryo.

[25] Urukiko rusanga ikibazo muri uru rubanza atari ukumenya niba Inteko Ishinga Amategeko ifite ububasha bwo gukora isobanurampamo ku ngingo z'Itegeko Nshinga, ahubwo ari ukumenya niba Urukiko rw'Ikirenga rufite ububasha bwo gusuzuma ikirego cyerekeranye no gusesengura Itegeko Nshinga ariko kidasaba gukuraho itegeko cyangwa ingingo y'itegeko inyuranije naryo.

[26] Mu bigaragara, nta rukiko rwahawe ububasha mu buryo butaziguye bwo guca urubanza rw'wareze asaba kivanaho cyangwa guhagarika igikorwa avuga ko kinyuranye n'Itegeko Nshinga. Nubwo bimeze gutyo, icyumvikana nuko inkiko arizo zifite inshingano yo guca imanza ndetse zikaba zidashobora kwiyambura ubwo bubasha ku mpamvu iyo ariyo yose. Ihame rusange nuko urukiko rudashobora kwanga guca urubanza rwitwaje ko ntacyo itegeko rivuga ku kirego rwashyikirijwe. Ibi bishimangirwa n'ingingo ya 6, igika cya 3 y'Itegeko N° 21/2012 ryo kuwa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbenezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsu aho igira iti "[.....]. Abacamanza ntibashobora kandi kwanga guca urubanza bitwaje impamvu iyo ari yo yose, n'iyi ntacyo itegeko ryaba riteganya, ridasobanutse mu buryo bwumvikana cyangwa ridahagije...". Inkiko nizo zifite ububasha n'inshingano byo guca imanza, igisigaye ni ukumenya urukiko rufite ububasha bwo kuburanisha ikirego cy'wareze asaba kivanaho cyangwa guhagarika igikorwa avuga ko kinyuranye n'Itegeko Nshinga nk'uko GREEN PARTY ibisaba.

[27] Itegeko Nshinga mu ngingo yaryo ya 145(3°) n'Itegeko Ngenga N°03/2012/0L ryo kuwa 13/06/2012 rigena imiterere, imikorere, n'ububasha by'Urukiko rw'Ikirenga mu ngingo yaryo ya 29(2°) biha Urukiko rw'Ikirenga ububasha bwo gufata icyemezo ku birego birebana n'uko amasezerano mpuzamahanga, amategeko ngenga, amategeko n'amategeko-teka anyuranye n'Itegeko Nshinga. Itegeko Nshinga ryemera ko itegeko ryose rinyuranye naryo ritagira agaciro ndetse rikanaha ububasha Urukiko rw'Ikirenga bwo gufata icyemezo ku birego birebana n'amategeko anyuranye naryo. Muri bene izo manza, Urukiko rusobanura itegeko cyangwa ingingo z'amategeko zisabirwa kivanwaho, zikagereranywa n'ingingo z'Itegeko Nshinga.

[28] Nyamara haba mu Itegeko Nshinga haba mu itegeko rigena imiterere, imikorere n'ububasha by'Urukiko rw'Ikirenga, nta hagaragara Urukiko cyangwa urundi rwego rwahawe ububasha bwo kuburanisha ibirego bisaba gukuraho igikorwa kinyuranye n'Itegeko Nshinga kivugwa mu ngingo ya 200 yaryo igihe cyaba gitanzwe.

[29] Mu bihugu nka Kenya na Uganda biri mu karere k'Afurika y'Iburasirazuba u Rwanda ruherereyemo, inkiko nkuru nizo zifite ububasha bwo kuburanisha ibirego byose zishyikirijwe bireba ingingo z'Itegeko Nshinga harimo no kuzisobanura. Mu Itegeko Nshinga rya Kenya ubwo bubasha buteganywa n'ingingo zaryo za 22, 23 n'iya 165 d<sup>1</sup> naho mu rya Uganda bugateganywa n'ingingo ya 137<sup>2</sup>.

[30] Mu gihugu cy'Afrika y'Epfo, Urukiko rurinda Itegeko Nshinga (Constitutional Court) rw'icyo gihugu rufite ububasha bwo kuburanisha ibibazo byose bijyanye naryo kandi rukanagira ububasha bwo kurisobanura. [167] 3) *The Constitutional Court (a) is the highest court of the Republic; and (b) May decide (i) Constitutional matters; and (ii) any other matter, if the Constitutional Court grants leave to appeal on the grounds that the matter raises an arguable point of law of general public importance which ought to be considered by that Court, and (c) makes the final decision whether a matter is within its jurisdiction [...]* 7) *A constitutional matter includes any issue involving the interpretation, protection or enforcement of the Constitution.*

[31] Muri Mauritius naho, ingingo ya 85 y'Itegeko Nshinga iha Urukiko rw'Ikirenga rw'icyo gihugu, ububasha bwo guca imanza zirebana no gusobanura ingingo z'Itegeko Nshinga ryacyo. Iyo ngingo ibivuga muri aya magambo “[.....] Where any question as to the interpretation of this Constitution arises in any court of law established for Mauritius (other than the Court of Appeal, the Supreme Court or a court martial) and the court is of opinion that the question involves a substantial question of law, the court shall refer the question to the Supreme Court”.

[32] Inkiko z'ibihugu bimwe na bimwe zaciye imanza ku bibazo birebana n'Itegeko Nshinga kandi nta tegeko rihari rigena mu buryo buziguze ko arizo zifite ububasha bwo kuburanisha ibibazo birebana n'Itegeko Nshinga. Nko muri Leta Zunze Ubumwe z'Amerika, ibyo byabaye mu manza zimwe na zimwe, uruzwi cyane ni urwa *Marbury v. Madison*<sup>3</sup> rwo mu 1803, n'izindi manza zarukurikiye. Nko mu rubanza *City Boerne vs Flores*, Urukiko rw'Ikirenga rwo muri Leta Zunze Ubumwe z'Amerika rwavuze ko Inteko Ishinga Amategeko y'icyo gihugu ifite ububasha bwo gushyira mu bikorwa (enforcement) Itegeko Nshinga binyuze mu gutora amategeko ariko ko idafite ububasha bwo gufata icyemezo ko Itegeko Nshinga ryishwe, ahubwo ko ubwo bubasha bufitwe n'inkiko<sup>4</sup>.

[33] Muri rusange, mu bindi bihugu imanza zirebana n'Itegeko Nshinga ziburanihwa n'Urukiko rw'Ikirenga cyangwa izindi nkiko nkuru zishinzwe kurinda Itegeko Nshinga (constitutional courts) bitewe n'igihugu. Izi nkiko nizo zifite ububasha bwo kuburanisha ibirego byose birebana n'Itegeko Nshinga.

[34] Hakurikijwe rero ibyasobanuwe mu bika bibanziriza iki, Urukiko rurasanga no mu Rwanda mu gihe Urukiko rw'Ikirenga arirwo rufite ububasha bwo gufata icyemezo ku birego birebana n'amategeko anyuranye n'Itegeko Nshinga, hakaba nta rukiko cyangwa urundi rwego rwahawe ububasha bwo kuburanisha ibirego byose birebana n'Itegeko Nshinga no kurisobanura, rufite n'ububasha bwo kuburanisha ibirego byerekeranye no gusobanura ingingo z'Itegeko Nshinga.

(1) *Any question as to the interpretation of this Constitution shall be determined by the Court of Appeal sitting as the Constitutional Court.*

(2) *When sitting as a Constitutional Court, the Court of Appeal shall consist of a bench of five members of that Court.*

(3) *A person who alleges that-*

(a) *an Act of Parliament or any other law or anything or done under the authority of any law; or*

(b) *any act or omission by any person or authority is inconsistent with or in contravention of a provision of this Constitution, may petition the Constitutional Court for a declaration to that effect, and for redress where appropriate.*
