Amategeko agenga imiburanishirize y'imanza – Gusubirishamo urubanza ku mpamvu z'akarengane – Ibarwa ry'igihe cyo gusaba gusubirishamo urubanza ku mpamvu z'akarengane – Gusaba gusubirishamo urubanza ku mpamvu z'akarengane bikorwa mu gihe kitarenze iminsi mirongo itatu (30) y'akazi ibarwa uhereye ku munsi umuburanyi ubisaba yamenyesherejweho imikirize yarwo, hatabariwemo umunsi w'imenyesha, iminsi y'impera y'icyumweru (week-ends) n'iminsi y'ikiruhuko yemewe n'amategeko.

Incamake y'ikibazo: Ku wa 30/03/2018 mu Karere ka Rusizi, habereye impanuka y'imodoka yo mu bwoko bwa NISSAN ifite ibyapa biyiranga C1914A, yari itwawe na SEHORANA ikaba yari ifite ubwishingizi muri SORAS Assurances Générales Ltd (SORAS) ubu yahindutse SANLAM Assurance Générales Plc (SANLAM) maze igonga Nshimiyimana imutera ubumuga buhoraho bungana na 60% ariko nyuma yo kongera gusuzumwa n'umuganga wa SORAS bigaragara ko yagize ubumuga buhoraho bungana na 40%. Nshimiyimana yatanze ikirego mu Rukiko Rwisumbuye rwa Rusizi rumugenya indishyi zinyuranye harimo n'indishyi z'ibangamirabukungu zabariwe ku mushahara wa Frw 5000 ku munsin kuko yari afite umurimo uzwi w'ubumotari. SANLAM ntiyishimiye iki cyemezo ikijurira mu rukiko rukuru ariko narwo rwemeza ko ubujurire bwayo nta shingiro bufite rugumsihaho icyemeozo cy'Urukiko rwisumbuye. Yaje kwandikira Perezida w'Urukiko rw'Ubujurire asaba ko urwo rubanza rwasubirwamo ku mpamvu z'akarengane nawe yandikira Perezida w'Urukiko rw'Ikirenga, uru rubanza ruhabwa Urukiko rw'Ikirenga maze rurusubiramo.

Mbere yo kwinjira mu mizi y'urubanza, Urukikorwabanje gusuzuma ikibazo kijyanye n'iyubahirizwa ry'ibihe byo gusubirishamo urubanza ku mpamvu z'akarengane kwakozwe n'urega hagamijwe kumenya niba SANLAM yarubahirije ibihe byo gusubirishamo urubanza ku mpamvu z'akarengane.

Uregwa we avuga ko urubanza rusubirishwamo ku mpamvu z'akarengane rwasomwe ku wa 12/03/2020 kandi ko rware rwarahawe itariki ruzasomerwaho ababuranyi bose bahari, ko kuba SANLAM yitwaza ko kopi y'urubanza yageze muri sisiteme itinze babona nta shingiro bifite kuko icyatinze kujya

muri sisiteme ari kopi y'urubanza naho icyemezo cyari cyafashwe cyagaragaraga mu nyandikomvugo y'isomwa ry'urubanza.

[1] Ku wa 30/03/2018 mu Mudugudu wa Gatare, Akagari ka Kabakobwa, Umurenge wa Gashonga ho mu Karere ka Rusizi, Intara y'Iburengerazuba habereye impanuka y'imodoka yo mu bwoko bwa NISSAN ifite ibyapa biyiranga C1914A, yari itwawe na SEHORANA Emmanuel ikaba yari ifite ubwishingizi muri SORAS Assurances Générales Ltd (“SORAS” muri uru rubanza) ubu yahindutse SANLAM Assurance Générales Plc (“SANLAM” muri uru rubanza) maze igonga Nshimiyimana Emmanuel imutera ubumuga buhoraho bungana na 60% ariko nyuma yo kongera gusuzumwa n’umuganga wa SORAS bigaragara ko yagize ubumuga buhoraho bungana na 40%.

[2] Nshimiyimana Emmanuel yareze SORAS mu Rukiko Rwisumbuye rwa Rusizi asaba indishyi zikomoka kuri iyo mpanuka maze ku wa 27/02/2019, urwo Rukiko ruca urubanza № RC 00135/2018/TGI/RSZ rwemeza ko SORAS igomba kumwishiura indishyi z'ibangamirabukungu zingana 7.085.817 Frw, ikamwishiura indishyi z'akababaro zingana na 432.000 Frw, indishyi z'ibangamira ry'uburanga zingana na 216.000 Frw, indishyi z'ibangamira ry'uburambe mu kazi zingana na 900.000 Frw, ikamusubiza 457.413 Frw yakoreshje yivuza no kugura icyemezo cyo mu Murenge, 100.000 Frw yakoreshje mu ngendo yivuza, 100.000 Frw y'ikurikiranarubanza 500.000 Frw y'ighembo cya Avoka, hiyongereyeho 20.000 Frw Nshimiyimana Emmanuel yatanzezo ingwate arega.

[3] SORAS yahise ijuririra icyo cyemezo mu Rukiko Rukuru, Urugereko rwa Rusizi, ivuga ko Urukiko Rwisumbuye rwa Rusizi rwageneye Nshimiyimana Emmanuel indishyi z'ibangamirabukungu hashingiwe ku mushahara muto fatizo ungana 5.000 Frw ku munsi, aho gushingira ku mushahara muto ntarengwa wemewe n'amategeko ungana na 3.000 Frw ku munsi kubera ko nta bimenyetso bifatika bigaragaza umushahara w'ukuri yakoreraga. Yanenze kandi ko Urukiko Rwisumbuye rwa Rusizi rwageneye Nshimiyimana Emmanuel indishyi z'ibangamiraburambe mu kazi kandi nta kimenyetso gifatika kigaragaza akazi gahoraho yakoraga.

Rwasanze ntaho ahuriye n'abagomba kubarirwa hashingiwe ku mushahara fatizo 3.000 Frw ku munsi bavuzwe mu rubanza № RCAA 0049/14/CS rwaciwe ku wa 25/11/2016 n'Urukiko rw'Ikirenga, SORAS igenderaho aho uwahohotewe aba akora umurimo adahemberwa, cyangwa iyo yakoraga gusa imirimo yo mu rugo, cyangwa adashobora kwerekana umusaruro we nyakuri ukomoka ku murimo. Rwongeraho kandi ko kubarirwa ku mushahara fatizo wa 5.000 Frw ku batwara abagenzi kuri moto mu Ntara y'Uburengerazuba, ari umurongo wafashwe n'Inkiko mu manza zitandukanye harimo urubanza № RCA 00279/2016/HC/KIG.

[6] Ku wa 20/05/2020 SORAS yahindutse SANLAM yandikiye Perezida w'Urukiko rw'Ubujurire isaba ko rubanza № RCA 0024/2019/HC/RSZ rwaciwe ku wa 12/03/2020 n'Urukiko Rukuru, Urugereko rwa Rusizi, rusubirwamo ku mpamvu z'akarengane, maze nyuma yo gusuzuma ubusabe bwayo, nawe yandikira Perezida w'Urukiko rw'Ikirenga asaba ko urubanza rwavuzwe rusubirwamo ku mpamvu z'akarengane.

[18] Ku byerekeye igithe umuburanyi amenyera imikirize y'urubanza, iningo ya 148 igika cya 2 y'Itegeko No 22/2018 ryo ku wa 29/04/2018 ryavuzwe haruguru iteganya ko umuburanyi wari uhari iburanisha ripfundikirwa, n'iyo yaba atari ahari umunsi w'isomwa ry'urubanza, afatwa nk'uwaneyi igithe urubanza rwasomewe. Ibi kandi uru Rukiko rwabigarutseho mu rubanza N° RS/REV/R.COM 00005/2017/SC Dunia Bakarani Faustin n'undi, baburanaga na Majyambere Silas n'abandi. Muri urwo rubanza, urukiko rwasuzumye ikibazo cyo kumenya niba DUNIA BAKARANI Faustin yarubahirije ibihe byo gusubirishamo urubanza iningo nshya biteganywa n'Itegeko hashingiwe ku gihe yamenyesherejwe imikirize yarwo, aho rwasanze umunsi urubanza rwasomeweho, kandi ababuranyi bari bamenyeshejwe, ari nawo ugomba guherwaho habarwa igithe cy'amezi abiri cyo gusubirishamo urubanza iningo nshya.²

Dosiye igaragaza kandi, nk'uko n'uhagarariye SANLAM yabisobanuriye urukiko mu iburanisha ryo ku wa 12/12/2022, ko ku wa 20/05/2020 aribwo SANLAM yandikiye Perezida w'Urukiko rw'Ubujurire isaba ko urubanza N° RCA 00024/2019/HC/RSZ rwasubirwamo ku mpamzu z'akarengane.

[20] Me Nkeza Sempundu Clément uhagarariye SANLAM avuga ko itariki ya 12/05/2020, ariyo ikwiye guherwaho habarwa ibihe byo gusubirishamo urubanza N° RCA 00024/2019/HC/RSZ ku mpamvu z'akarengane ngo kuko ari bwo kopi yarwo yashyiriwe muri sisitemu. Avuga ko asanga SANLAM yarubahirije ibihe biteganywa n'amategeko kuko yandikiye Perezida w'Urukiko rw'Ubujurire ku wa 20/05/2020, nyuma y'iminsi umunani (8) gusa ibonye kopi y'urubanza. Ibi abivuga yifashisha icyemezo cy'uru Rukiko mu rubanza N° RS/INJUST/RCOM 00003/2019/SC cyafatiwe mu ntebe, mu iburanisha ryo ku wa 14/09/2020 haburana Access Bank na SOTIRU Ltd, aho avuga ko Urukiko rwemeje ko kumenyeshwa imikirize y'urubanza bishingira ku gihe kopi yarwo yashyiriwe muri sisitemu.

[21] Urukiko rusanga ibivugwa n 'uhagarariye SANLAM nta shingiro bifite kuko icyemejwe mu iburanisha ry'urwo rubanza ari uko mu manza umuburanyi yaburanye akamenyeshwa umunsi w'isomwa kandi uwo munsi ntuhinduke, uwo munsi w'isomwa ariwo ufatwa ko yamenyeshejweho imikirize y'urubanza.
