Abahagarariye Leta y'u Rwanda muri uru rubanza, bavuga ko Uwatanze ikirego ntaho agaragaza ko ingingo baregera zinyuranyije n'Itegeko Nshinga, ko bibanda ahanini ku miterere y'Ubushinjacyaha, bakabushyira mu Butegetsi Nyubahirizategeko ariko bakibagirwa ko bunafatwa nk'igice cy'Ubutegetsi bw'Umucamanza. Bavuga ko itandukaniro ry'imikurikiranire y'icyaha mu Rwanda no mu bindi bihugu, ari uko mu Rwanda igenzura ry'inyandiko z'isaka rikorwa n'inkiko nyuma y'isaka, mu gihe mu bindi bihugu urupapuro rw'isaka cyangwa urwo kumviriza itumanaho rushyirwaho umukono n'Umucamanza mbere y'uko rukoresha. [45] Bavuga kandi ko ingingo ya 17 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha ishyiraho inzego zishinzwe iperereza ndetse ko ariyo Umugenzacyaha ashingiraho agitangira iperereza ry'ibanze, ikaba iri no mu zimuha ububasha bwo kubaza uwo ari we wese akeka ko afite amakuru ku mikorere y'icyaha. Basobanura ko amagambo umuntu uwo ari we wese atavuze ukurikiranweho icyaha kubera ko mu iperereza ry'ibanze ukurikiranweho icyaha aba ataramenyekana, ko hari n'igihe umuntu atangira abazwa nk'umutangabuhamya bikarangira bigaragaye ko ari we ugomba gukurikiranwa.

[46] Basanga gutanga amakuru no kwishinja ari ibintu bibiri bitandukanye, ko kwishinja bishoboka gusa iyo wamenyeshejwe ibyaha uregwa, ugategekwa kubatangira ibisobanuro, naho gutanga amakuru bikaba bidakorwa gusa n'abaregwa, ko niyo bayatanze aba aribo babishatse. Basobanura ko amategeko ateganya uburyo amakuru ajyanye n'imikorere y'icyaha atangwa, ko umuntu wese wisobanura ku cyaha abanza kumenyeshwa ibyo aregwa, akagaragarizwa ko arimo kubazwa, akamenyeshwa n'uburenganzira bwe harimo n'ubwo guceceka, kutishinja ndetse no kubazwa yunganiwe.

[47] Bakomeza bavuga ko gutanga amakuru bitavuze kuyatangira imbere y'itangazamakuru cyangwa ko uyatanga agomba kuba ufuzwe, ahubwo ko icyangombwa ari uko mu gihe abajijwe amakuru ategetswe kuyatanga, kandi ko ibyo bitandukanye no kwishinja kubera ko amakuru atangwa mu rwego rwo gufasha mu iperereza. Basobanura ko intego y'amakuru atangwa mu gihe cy'iperereza atari ukugira ngo yohererezwe itangazamakuru ahubwo ari ukugaragaza imikorere y'icyaha n'abakigizemo uruhare.

[48] Basobanura ko ntaho ingingo iregerwa iteganya ko ukekwa icyaha agomba kwiregurira imbere y'itangazamakuru, ndetse ko nta n'indi ngingo y'Itegeko Murangwa Edward agaragaza yaba ibiteganya ityo. Bakomeza bavuga ko nubwo Ubugenzacyaha bwitwararika bukabariza abantu ahantu hatuje kandi hatekanye, bitavanaho ko itangazamakuru rishobora kubutanga ahakorewe icyaha, bigatuma mu gihe cy'ibazwa, itangazamakuru rifata uwo muntu amajwi cyangwa n'amashusho Umugenzacyaha atabizi, ariko ko nabyo bidakwiye gufatwa nk'ikibazo cyatuma ingingo ya 10, igika cya mbere, agace ka 8°, y'Itegeko N° 12/2017 ryo ku wa 07/04/2017 ryavuzwe haruguru iregerwa nk'inyuranyije n'ingingo ya 29 y'Itegeko Nshinga, kuko ari ikibazo cy'imikorere gishobora gukemurwa hataregwe ivanwaho ry'itegeko kuko rinyuranyije n'Itegeko Nshinga.

[49] Basoza bavuga ko ibijyanye n'icyifuzo cya Murangwa Edward cy'uko uru Rukiko rwategeka inzego za Leta zifite aho zihuriye n'iperereza kudashyira mu itangazamakuru umuntu ukurikiranyweho icyaha yambaye amapingu cyangwa ahambiriye kugira ngo ahatwe ibibazo bidakwiye gusuzumwa ngo bifatweho icyemezo kuko bidafitanye isano n'icyaregwe.

## **UKO URUKIKO RUBIBONA**

[50] Ingingo z'amategeko Murangwa Edward asaba Urukiko kwemeza ko zinyuranyije n'Itegeko Nshinga zivuga ku bintu binyuranye, ariko ibyo yagarutseho mu bisobanuro yatanze ni ibirebana n'isaka, kimwe n'ibirebana no gutegeka umuntu gutanga amakuru no kubaza umuntu uwo ari we wese ukekwa ko afite amakuru yafasha mu iperereza. Ibyo rero nibyo n'Urukiko rwibandaho mu gusuzuma ikirego yarugejejeho.

### **a. Ibyerekeye isaka**

#### **i) Ku bijyanye n' isaka rishingiye ku ruhushya rw'isaka**

[51] Ingingo ya 10, igika cya mbere, igice cya mbere cy'agace ka gatatu, y'Itegeko N° 12/2017 ryo ku wa 07/04/2017 rishyiraho Urwego rw'Igihugu rushinzwe Ubugenzacyaha rikanagena inshingano, ububasha, imitunganyirize n'imikorere byarwo iteganya ko hakurikijwe amategeko abigenga, RIB (Rwanda Investigation Bureau) ifite ububasha bukurikira: [...] gusaka umuntu, kwinjira mu nyubako

cyangwa ahantu hakekwaho kuba hafitanye isano n'amakuru ashakwa hashingiwe ku ruhushya rwo gusaka [...].

[52] Ingingo ya 55, igika cya mbere n'icya kabiri, y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha iteganya ko Umugenzacyaha mu gihe asanga ibimenyetso akeneye bigizwe n'impapuro, inyandiko n'ibindi bintu bibitswe n'ukekwa icyaha cyangwa se undi wese, ashobora kujya gusaka aho biherereye yitwaje uruhushya rwo gusaka ahabwa n'Ubushinjacyaha. Umushinjacyaha ushinze gutegura dosiye y'urubanza ashobora nawe kujya gusaka aho icyaha cyakorewe cyangwa ahandi hantu hose hashobora kuboneka ibimenyetso byatuma ukuri kujya ahagaragara. Umushinjacyaha ashobora gushinga iyo mirimo Umugenzacyaha.

[53] Ingingo ya 61 y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 rimaze kuvugwa iteganya ko urwandiko rwo gusaka ari icyemezo gitangwa n'Umushinjacyaha bitangiwe uruhushya n'aba bakurikira:

- 1° Umushinjacyaha Mukuru;
- 2° Umushinjacyaha Mukuru wa Gisirikare ku bireba abasirikare n'uwo bafatanyije icyaha;
- 3° Umushinjacyaha ku Rwego rw'Igihugu;
- 4° Umushinjacyaha uyobora Ubushinjacyaha ku Rwego Rwisumbuye;
- 5° Umushinjacyaha ku Rwego rw'Ibanze.

Urwandiko ruvugwa mu gika cya mbere cy'iyi ngingo ruha ugomba kugishyira mu bikorwa uburenganzira bwo kujya ahantu hagenwe mu rwandiko, kugira ngo abe yatahura ibimenyetso cyangwa ibintu byagaragazaukuri kw'icyaha n'ugikekwaho.

[54] Urukiko rurasanga itegeko ubwaryo ridasobanura isaka icyo ari cyo. Abahanga mu mategeko yerekeye imiburanishirize y'imanza nshinjabyaha bavuga ko isaka ari uburyo urwego rubifitiye ububasha rukoresha imbaraga rukinjira mu nyubako cyangwa inkengeru zayo, hubahirijwe uburyo buteganywa ndetse n'ibisabwa n'amategeko, kugira ngo hagaragazwe ikorwa ry'icyaha, hakusanywe ibimenyetso by'ikorwa ry'icyaha, hagire ibifatirwa cyangwa hafatwe abakekwaho icyaha cyangwa ibyitso byabo<sup>18</sup>. Basobanura ko isaka rikorwa iyo hari impamvu zifatika zituma habaho gukeka ko hari ikintu gifitwe n'umuntu runaka cyangwa gihereye ahantu runaka kandi gishobora kugaragaza ukuri mu rubanza nshinjabyaha<sup>19</sup>.

[55] Impamvu zifatika zituma habaho isaka (*reasonable grounds/probable cause*) zibaho iyo inzego zibifitiye ububasha, mu bwitonzi n'ubushishozi bwazo, zabonye amakuru yizewe yatuma zikeka ko hari ibimenyetso bijyanye n'ikorwa ry'icyaha byagaragazwa n'uko hakozwe isaka<sup>20</sup>. Mu yandi magambo, isaka rikorwa hagamijwe gushaka cyangwa kuzuza ibimenyetso mu rubanza nshinjabyaha. Ni igikorwa cy'iperereza, ibyo bikaba binemezwa n'umuhanga Michel Franchimont<sup>21</sup>.

[56] Ingingo z'amategeko zavuzwe haruguru zumvikanisha ko igikorwa cyo gusaka nk'uko kimaze gusobanurwa, kiyoborwa n'Umugenzacyaha cyangwa Umushinjacyaha ariko hashingiwe ku ruhushya rw'isaka rwatanze n'Ubuyobozi bw'Ubushinjacyaha. Murangwa Edward yemera ko isaka rigomba

gukorwa n'Ubugenzacyaha cyangwa n'Ubushinjacyaha; icyo atemera, ari naho hashingiye ikirego cye, ni ukuba uruhushya rw'isaka rutangwa n'Ubushinjacyaha aho gutangwa n'Urukiko. Asobanura ko kuba uruhushya rw'isaka rudatangwa n'Urukiko bituma ingingo z'amategeko yaregeye zinyuranya n'ingingo ya 13, iya 14, iya 23, iya 24, iya 29, iya 43 n'iya 61 z'Itegeko Nshinga.

[57] Urukiko rurasanga nubwo Murangwa Edward afatira hamwe izi ngingo z'Itegeko Nshinga, ziri mu byiciro bitandukanye:

- a. icyiciro kirebana n'uburenganzira n'ubwisanzure;
- b. icyiciro kirebana no guteza imbere no kurinda uburenganzira n'ubwisanzure;
- c. icyiciro kirebana n'Inzego z'Ubutegetsi za Leta.

[58] Ingingo ya 13, iya 14, iya 23, iya 24 n'iya 29 ziri mu cyiciro kirebana n'uburenganzira n'ubwisanzure bwa muntu. By'umwihariko, ingingo ya 13 n'iya 14 zishyiraho uburenganzira bwo kudahungabanywa k'umuntu haba mu mutwe cyangwa ku mubiri. Ingingo ya 13 y'Itegeko Nshinga igira iti: umuntu ni umunyagitinyiro kandi ni indahungabanywa. Leta ifite inshingano zo kumwubaha, kumurinda no kumurengera. Naho ingingo ya 14 ikagira iti: umuntu wese afite uburenganzira bwo kudahungabanywa ku mubiri no mu mutwe. Ntawe ushobora kwicwa urubozo, gukorerwa ibibabaza umubiri cyangwa ngo akorerwe ibikorwa by'ubugome, ibikorwa bidakwiye umuntu cyangwa bimutesha agaciro. Ntawe ushobora gukorerwaho igerageza atabyiyemereye. Uburyo bwo kubyemera kimwe n'ubw'iryo gerageza bugenwa n'Itegeko.

[59] Ingingo ya 23 n'iya 24 igika cya mbere z'Itegeko Nshinga, zivuga ku burenganzira ku mibereho bwite, ubwisanzure n'umutekano bya muntu. Ingingo ya 23 igira iti: imibereho bwite y'umuntu, iy'umuryango we, urugo rwe cyangwa ubutumwa yoherezanya n'abandi ntibishobora kuvogerwa mu buryo bunyuranyije n'amategeko; icyubahiro n'agaciro ke bigomba kubahirizwa. Urugo rw'umuntu ntiruvogerwa. Ntishobora gukorwa isakwa mu rugo cyangwa kurwinjiramo kubera impamvu z'igenzura nyirarwo atabyemereye, keretse mu bihe no mu buryo biteganyijwe n'amategeko. Ibinga ry'amabarurwa n'iry'itumanaho ntirishobora kuzitirwa keretse mu bihe no mu buryo biteganywa n'amategeko. Naho ingingo ya 24, igika cya mbere ivuga ko ubwisanzure n'umutekano bya muntu byubahirizwa na Leta...

[60] Ingingo ya 24, igika cya kabiri n'icya gatatu, ndetse n'ingingo ya 29 y'Itegeko Nshinga zishyiraho ihame ry'ubutabera buboneye. Ingingo ya 24, igika cya kabiri n'icya gatatu igira iti: ntawe ushobora gukurikiranwa, gufatwa, gufungwa cyangwa guhanirwa icyaha keretse mu gihe biteganywa n'amategeko akurikizwa mu gihe icyaha akurikiranweho cyakorewe. Ntawe ushobora gukorerwa igenzurwa keretse mu bihe no mu buryo buteganyijwe n'Itegeko kandi kubera impamvu zishingiye ku ituze rusange rya rubanda cyangwa ku mutekano w'igihugu.

[61] Ingingo ya 29 y'Itegeko Nshinga iteganya ko buri muntu wese afite uburenganzira ku butabera buboneye, burimo uburenganzira bwo:

- 1° Kumenyeshwa imiterere n'impamvu z'icyaha akurikiranweho, kwiregura no kunganirwa;
- 2° Gufatwa nk'umwera kugeza igihe Urukiko rubifitiye ububasha rumuhamije icyaha;
- 3° Kuburanira imbere y'Urukiko rubifitiye ububasha;
- 4° Kudakurikiranwa, kudafatwa, kudafungwa cyangwa kudahanirwa ibyo yakoze cyangwa atakoze, iyo amategeko y'Igihugu cyangwa amategeko mpuzamahanga atabifataga nk'icyaha igihe byakorwaga. Ibyaha n'ibihano bijyanye nabyo biteganywa n'amategeko.
- 5° kutaryozwa icyaha atakoze; uburyozwacyaha ni gatozi ku wakoze icyaha; [...]

[62] Ingingo ya 43 y'Itegeko Nshinga yo iri mu cyiciro cyo guteza imbere no kurinda uburenganzira n'ubwisanzure bwa muntu, igira iti: ubutegetsu bw'Ubucamanza nibwo murinzi w'uburenganzira n'ubwisanzure bwa muntu. Iyo nshingano yubahirizwa mu buryo buteganywa n'iri Tegeko Nshinga n'andi mategeko. Naho ingingo ya 61, igika cya mbere n'icya kabiri, y'Itegeko Nshinga iri mu cyiciro cy'Inzego z'Ubutegetsu bwa Leta, igira iti: inzego z'Ubutegetsu bwa Leta ni izi zikurikira:

1° Ubutegetsu Nshingamategeko;

2° Ubutegetsu Nyubahirizategeko;

3° Ubutegetsu bw'Ubucamanza

Ubu butegetsu uko ari butatu buratandukanye kandi buri butegetsu burigenga, ariko bwose bukuzuzanya [...].

[63] Urukiko rusanga ahari ipfundo ry'ikibazo, ari ukumenya niba kuba uruhushya rw'isaka rudatangwa n'Urukiko ahubwo rugatangwa n'Ubushinjacyaha, byaba binyuranyije na zimwe cyangwa ingingo zose z'Itegeko Nshinga zavuzwe haruguru nk'uko Murangwa Edward abivuga.

[64] Iyo icyaha gikozwe, inzego zibishinzwe ziba zigomba kwihutira gushaka no kwegeranya ibimenyetso byafasha gutahura uwagikoze. Muri uko gushaka no kwegeranya ibimenyetso, hakenerwa gukora isaka ahantu hose hakekwa ko byaboneka harimo aho abantu batuye, aho bakorera, n'ahandi. Ni igikorwa kiba kigomba kuba mu buryo bwihuse, kugirango hatabaho kurigisa cyangwa kwangiza ibimenyetso.

[65] Ingingo ya 23 y'Itegeko Nshinga ibuza kuvogera umuntu, mu buryo bunyuranyije n'amategeko, mu mibereho ye bwite, iy'umuryango we, urugo rwe, no mu butumwa yohererezanya n'abandi. Iyi ngingo yemera ariko ko hashobora kubaho isakwa mu bihe no mu buryo buteganywa n'itegeko. Ingingo ya 24 y'Itegeko Nshinga yongeraho ko igenzurwa (*mesures de sûreté*) rishobora kubaho mu bihe no mu buryo buteganyijwe n'Itegeko kandi kubera impamvu zishingiye ku ituze rusange rya rubanda cyangwa ku mutekano w'igihugu. Ibi bivuze ko ihame ryo kutavogerwa riteganywa n'izi ngingo atari ndakuka (*absolu*), ahubwo rifite imbibi rigarukiraho (*limitations*), ariko gusa mu bihe no mu buryo bugenwa n'itegeko. Izi ngingo kandi ntiziha ububasha bwo gusaka urwego runaka, cyangwa ngo zigene uburyo isaka rigomba gukorwamo, ahubwo ziha itegeko ububasha bwo kubigena.

[66] Mu rwego rwo gushyira mu bikorwa ibiteganyijwe mu ngingo za 23 na 24 zimaze kuvugwa, hashyizweho Itegeko N° 12/2017 ryo ku wa 07/04/2017 rishyiraho Urwego rw'Igihugu rushinzwe Ubugenzacyaha rikanagena inshingano, ububasha, imitunganyirize n'imikorere byarwo, ndetse n'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha. Muri aya mategeko yombi, Umushingamategeko yasobanuye uburyo isaka rigomba gukorwamo, aha n'ububasha bwo gusaka inzego zishinzwe iperereza, ni ukuvuga Ubugenzacyaha n'Ubushinjacyaha hashingiwe ku biteganywa mu ngingo ya 9,2° y'Itegeko N° 12/2017 ryo ku wa 07/04/2017<sup>22</sup>; n'ingingo ya 17, igika cya 1 n'icya 2, y'Itegeko N° 027/2019 ryo ku wa 19/09/2019<sup>23</sup>.

[67] Ubushinjacyaha nk'urwego rukuriye igikorwa cy'iperereza, nibwo itegeko ryahaye ububasha bwo gutanga uruhushya rwo gusaka. Mu bihugu uruhushya rwo gusaka rutangwa n'Umucamanza, hari ibigira Umucamanza wihariye uba ushinze gukora iperereza no gukurikirana ibikorwa by'iperereza bita "*juge d'instruction*", ukora ku madosiye aba yashyikirijwe n'Ubushinjacyaha. Uyu mucamanza

ntajya mu iburanisha, kugirango hatabaho kubangikanya imirimo yo gukurikirana ibyaha no kubiburanisha, itagomba ubundi kubangikanywa. Urugero rw'ibyo bihugu ni nk'Ubwami bw'Ububiligi, Ubufaransa, Kameruni n'ibindi.

[68] Mu Bwami bw'Ububiligi, “*juge d'instruction*” nawe ubwe ashobora gusaka abisabwe cyangwa abyibwirije inyubako y'ukekwa icyaha cyangwa ahandi hantu aho ariho hose kugira ngo afatire impapuro cyangwa ibindi ibintu byatuma hagaragazwa ukuri<sup>24</sup>. Ni ukuvuga ko muri icyo gikorwa juge d'instruction ari urwego rw'iperereza. Ibi ni nako bimeze mu Bufaransa, aho juge d'instruction akora cyangwa agakurikirana ibikorwa byose bijyanye n'iperereza (birimo n'igikorwa cyo gusaka)<sup>25</sup>.

[69] Mu gihugu cya Kameruni, inyandiko y'isaka ishobora gutangwa n'Umushinjacyaha cyangwa na juge d'instruction<sup>26</sup>, uyu akaba ashobora no gukora isaka ubwe<sup>27</sup>. Mu Bwami bw'Ububiligi naho Umushinjacyaha ashobora gusaka atagombye guhabwa uruhushya na juge d'instruction, igihe habayeho gufatirwa mu cyuho<sup>28</sup>.

[70] Hari ibindi bihugu uruhushya rw'isaka rutangwa n'Urukiko, nko muri Afurika y'Epfo, muri Leta Zunze Ubumwe za Amerika, mu Bwongereza<sup>29</sup>, muri Canada n'ahandi. Muri Afurika y'Epfo, ingingo ya 21, igika cya mbere, y'Itegeko ryerekeye imiburanishirize y'imanza z'inshinjabyaha (*Criminal Procedure Act, 1977*) ivuga ko uruhushya rw'isaka rushobora gutangwa n'Urukiko iyo, nyuma y'indahiro y'urusaba, Urukiko rugaragarijwe ko hari impamvu zifatika zituma habaho gukuka ko hari ikintu gifitwe cyangwa kigenzurwa n'umuntu runaka cyangwa gihereye mu nyubako iri mu ifasi yarwo. Iyi ngingo iteganya ko urwo ruhushya rushobora no gutangwa n'Umucamanza mu gihe cy'iburanisha iyo bimugaragariye ko ari ngombwa<sup>30</sup>.

mu itangwa n' iyandikwa ry'uruhushya rw'isaka bidatera ikibazo<sup>53</sup>. Ibi ni nabyo byemejwe mu rubanza Leotsakos yaregagamo Igihugu cy'Ubugereki<sup>54</sup>.

[84] Mu rundi rubanza rwaciwe n'Urukiko rw'Ibihugu by'Uburayi rushinzwe uburenganzira bwa muntu, Gutsanovi yaregagamo Igihugu cya Bulgarie, hari hakozwe isaka mu rugo rw'urega nta ruhushya rwatanzwe n'Umucamanza, hashingiwe ku biteganywa n'amategeko agenga imiburanishirize y'imanza z'inshinjabyaha muri icyo Gihugu<sup>55</sup>. Urukiko rwasobanuye ko mu bihe nk'ibyo, impungenge z'uko nta ruhushya rwatanzwe n'Umucamanza zivanwaho n'igenzura rishobora gukorwa nyuma n'Urukiko ku bijyanye no kuba iryo saka ryari ngombwa kandi ko ryubahirije amategeko<sup>56</sup>.

[85] Mu rubanza Heino yaburanaga na Finland, Urukiko rw'Ibihugu by'Uburayi rushinzwe uburenganzira bwa muntu rwasanze igishobora kubangamira uburenganzira bw'usakwa ari ukuba adashobora kwiyambaza Urukiko mbere cyangwa nyuma y'isaka. Kuba umuntu wasatswe adashobora kwiyambaza inkiko nyuma y'isaka kugira ngo agaragaze inenge ziri mu cyemezo cy'isaka cyangwa uburyo isaka ryakozwe, bituma uwo muturage atarengerwa bihagije n'itegeko nyamara ari uburenganzira bwe mu gihugu kigendera ku mategeko na demokarasi<sup>57</sup>.

[86] Uyu murongo wongeye kwemezwa mu rubanza Zosymov yaburanaga na Ukraine, aho Urukiko rw'Ibihugu by'Uburayi rushinzwe uburenganzira bwa muntu rwasanze kuba itegeko ryerekeye imiburanishirize y'imanza nshinjabyaha rya Ukraine ritaganywa ko nta muntu wasatswe wemerewe kuregera icyemezo cy'isaka cyangwa uburyo isaka ryagenze adahuje ikirego cye n'icy'Ubushinjacyaha ku cyaha cyatumye isaka rikorwa binyuranyije n'uburenganzira umuturage ateganyirizwa n'ingingo ya 8 y'Amasezerano y'Ibihugu by'Uburayi yerekeye uburenganzira bwa muntu. Muri urwo rubanza, ikirego cy'umuntu wasatswe cyari cyanze kwakirwa kuko nyuma y'isaka Ubushinjacyaha bwamaze imyaka myinshi nta kirego buratanga, ari nabyo byaburijemo ikirego cy'uware warasatswe wavugaga ko uburenganzira bwe bwavogerewe<sup>58</sup>.

h. Kuba, umuntu ugomba gusakwa yambitswe ubusa cyangwa mu mubiri ashobora kwihitiramo umuherekeza w'umuganga, uwo bashyingiranywe cyangwa undi muntu wese mukuru yihitiyemo (ingingo ya 56, igika cya 3).

[90] Urukiko rurasanga ingamba zashyizweho n'ingingo za 55, 56, 60 na 64 z'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryavuzwe haruguru zisobanutse kandi zumvikana ku bijyanye no kubahiriza uburenganzira bw'umuturage ugiye gusakwa, no gukumira ko habaho kurengera. Ku bijyanye n'inzira umuturage yanyuramo kugirango agaragarize inkiko ibitubahirijwe mu byo amategeko ateganya, kandi asabe ko bikosorwa, ingingo ya 43 y'Itegeko Nshinga iha inkiko inshingano zo kuba umurinzi w'uburenganzira n'ubwisanzure bwa muntu, naho ingingo yaryo ya 23, igika cya kabiri, igateganya ko isaka rigomba gukorwa mu bihe no mu buryo biteganyijwe n'amategeko.

[91] Urukiko rusanga iyo hari ibiteganywa n'amategeko bitubahirijwe mu gihe cy'isaka, uwakorewe isaka ashobora kwiyambaza inkiko kugirango aharanire uburenganzira bwe bwahungabanyijwe. Muri urwo rwego, ingingo ya 76,2° y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha iha Umucamanza inshingano zo gusuzuma ibyakozwe mu gihe cy'iperereza bitubahirije amategeko, iyo asuzuma ikirego ku ifunga n'ifungurwa ry'agateganyo. Iyo ngingo iteganya ko Umucamanza uburanisha ibirego by'ifunga ry'agateganyo afite inshingano zirimo izo gusuzuma ko ibihe by'ifunga n'ubundi burenganzira bw'ukekwa icyaha bwubahirijwe mu gihe cy'iperereza.

[92] Na none, uregwa ashobora kugaragariza Umucamanza uburanisha urubanza rwe mu mizi ibyo asanga bitarubahirije amategeko mu gihe cy'iperereza, harimo n'ibyerekeye isaka. Igihe Umucamanza asanze hari ibimenyetso byabonetse mu isaka ridakurikije amategeko, abitesha agaciro. Ku muntu waba warakorewe isaka, ariko ntakorere dosiye ngo agezwe imbere y'Umucamanza, aba afite uburenganzira bwo kuregera indishyi ku byaba byarakozwe mu buryo bunyuranyije n'amategeko mu rubanza mbonezamubano.

## **ii) Ku bijyanye n'isaka ritatangiwe uruhushya**

[93] Ingingo ya 55, igika cya 4, y'Itegeko N° 027/2019 ryo ku wa 19/09/2019 ryerekeye imiburanishirize y'imanza z'inshinjabyaha iteganya ko iyo ukekwa icyaha afatiwe mu cyuho cyangwa asa n'uwagifatiwemo, ibijyanye no kwitwaza uruhushya rw'isaka ku mugenzacyaha cyangwa kubahiriza amasaha y'isaka bishobora kutubahirizwa. Buri gihe isaka rikorwa hari abahagarariye ubuyobozi bw'inzego z'ibanze bw'aho icyo gikorwa kibera. Naho ingingo ya 56, igika cya 2, y'iryo Tegeko ikagira iti: uretse igihe umuntu afatiwe mu cyuho, Umugenzacyaha cyangwa Umushinjacyaha ntashobora gukoresha isaka umuntu yambitswe ubusa cyangwa mu mubiri atabihereye uruhushya n'Umushinjacyaha uyobora urwego rw'Ubushinjacyaha akoreramo. Iryo saka rikorwa na muganga wenyine.

[94] Ingingo ya 3 y'Itegeko N° 12/2017 ryo ku wa 07/04/2017 rishyiraho Urwego rw'Igihugu rushinzwe Ubugenzacyaha rikanagena inshingano, ububasha, imitunganyirize n'imikorere byarwo iteganya ko Urwego rw'Ubugenzacyaha rushobora gusaka umuntu cyangwa ibintu, kwinjira mu nyubako cyangwa ahantu nta ruhushya rwo gusaka iyo hari impamvu zikurikira:

a. Impamvu zifatika zituma rukeka ko icyaha kirimo gukorwa cyangwa kigiye gukorwa;

b. Ibimenyetso bifatika byerekana ko mu nyubako cyangwa ahantu hari ikintu cyakoreshejwe mu gukora icyaha cyangwa gikenewe ku mpamvu z'iperereza;

c. Ibimenyetso bikomeye bigaragaza ko umuntu wakoze icyaha ari aho hantu kandi agomba guhagarikwa.

Muri icyo gihe, hakorwa inyandikomvugo y'isaka hakanakorwa raporo igaragaza impamvu iryo saka ryakozwe nta ruhushya rwo gusaka [...].

[95] Urukiko rurasanga isaka nta ruhushya rigamije kwirinda ko gutinda kuruhabwa biburizamo icyo iryo saka ryari rigamije. Ntabwo Umushinjacyaha cyangwa Umugenzacyaha yarebera ikorwa ry'icyaha cyangwa ngo yirengagize ibimenyetso abonye by'uko hari icyaha cyakozwe cyangwa kigiye gukorwa. Ahubwo afite inshingano zo kwita ndetse no kuba yafatira ibimenyetso abonye atabiteganyaga bimugaragariza ko hari icyaha cyakozwe, kirimo gukorwa cyangwa kirimo gutegurwa.

[96] Urukiko rurasanga akenshi abagenzacyaha biyambazwa mu buryo bwihutirwa, hari nubwo basabwa guherekeza abapolisi bagiye gutabara ahantu runaka cyangwa gutegura imitego yatezwe n'abashaka gukora ibyaha. Ubwihutirwe bwa bene ibyo bikorwa nibwo bwatumye Umushingamategeko ateganya ko Umugenzacyaha cyangwa Umushinjacyaha ashobora kutabona umwanya wo kujya gusaba urwego rubishinzwe uruhushya rw'isaka iyo umuntu ugomba gusakwa afatiwe mu cyuho, asa n'ugifatiwemo cyangwa se iyo hari imwe mu mpamvu zivugwa mu ngingo ya 3 y'Itegeko N° 12/2017 ryo ku wa 07/04/2017 zavuzwe haruguru.

[97] Urukiko rusanga mu rwego rwo gukumira ko uburenganzira bw'umuntu ugiye gusakwa nta ruhushya bwavogerwa, itegeko ryateganyije ko isaka iryo ariryo ryose rikorerwa inyandikomvugo<sup>59</sup>. Ku muntu ufatiwe mu cyuho cyangwa usa n'ugifatiwemo, isaka rigakorwa hari abayobozi b'inzeho z'ibanze, Umugenzacyaha akaba agomba gukora raporo igaragaza impamvu zatumye isaka rikorwa nta ruhushya ritangiwe. Urukiko rusanga izi ngamba zashyizweho n'Umushingamategeko zigamije gukumira ko habaho kurengera kw'abashinzwe igikorwa cy'isaka, kandi nk'uko byasobanuwe harugu, igihe habayeho kutubahiriza amategeko, uwakorewe isaka aba afite uburenganzira bwo kwiyambaza inkiko.

[98] Hashingiwe ku mategeko yagaragajwe no ku bisobanuro byose byatanzwe, Urukiko rurasanga kuba uruhushya rw'isaka rudatangwa n'Urukiko ahubwo rugatangwa n'Ubushinjacyaha, cyangwa kuba harateganyijwe ibihe isaka rishobora gukorwa ritangiwe uruhushya, bitanyuranyije n'ingingo ya 13, iya 14, iya 23, iya 24, iya 29, iya 43 n'iya 61 z'Itegeko Nshinga.

**b. Ibyerekeye gutegeka umuntu gutanga amakuru no kubaza umuntu uwo ari we wese ukekwa ko afite amakuru yafasha mu iperereza**

[99] Ingingo ya 10, agace ka 8, y'Itegeko N° 12/2017 ryo ku wa 07/04/2017 rishyiraho Urwego rw'Igihugu rushinzwe Ubugenzacyaha rikanagena inshingano, ububasha, imitunganyirize n'imikorere byarwo iteganya ko hakurikijwe amategeko abigenga, RIB ifite ububasha bwo gutegeka umuntu gutanga amakuru no kubaza umuntu uwo ari we wese ukekwa ko afite amakuru yafasha mu iperereza.

[100] Naho ingingo ya 29, igika cya mbere, agace ka 2°, y'Itegeko Nshinga iteganya ko buri muntu wese afite uburenganzira ku butabera buboneye, burimo uburenganzira bwo: [...] gufatwa nk'umwerekwese kugeza igihe Urukiko rubifitiye ububasha rumuhamije icyaha.

[101] Urukiko rurasanga ihame ry'uburenganzira ku butabera buboneye ryaragarutsweho mu rubanza rwa Kabasinga Florida rwaciye n'uru Rukiko ku wa 04/12/2019. Muri uru rubanza, Urukiko

Abahagarariye Leta y'u Rwanda bavuga ko uburenganzira ku butabera buboneye butangirira imbere y'inkiko, ariko mu myanzuro yabo ntibagaragaza aho babishingira. Mu rubanza rwa Kabasinga Florida rwavuzwe haruguru, Urukiko rwasanuye ko mu manza nshinjabyaha, uburenganzira ku butabera buboneye butangirana n'ibikorwa by'iperereza, bugakomereza ku bikorwa by'ikurikiranacyaha, iby'iburanisha n'itangwa ry'ibihano ku byaha biteganyijwe n'amategeko ahana<sup>61</sup>.

[103] Urukiko rurasanga rero, uburenganzira ku butabera buboneye, cyane cyane ubwo kumenyeshwa imiterere n'impamvu z'icyaha umuntu akurikiranyweho, kwiregura no kunganirwa, n'ubwo gufatwa nk'umwere kugeza igihe Urukiko rubifitiye ububasha rumuhamije icyaha, bidatangirana no kuregerwa Urukiko nk'uko abahagarariye Leta y'u Rwanda bashaka kubyumvikanisha. Urukiko rurasanga ihame ryo gufatwa nk'umwere kugeza igihe Urukiko rubifitiye ububasha rufatiye icyemezo ndakuka, rigomba kubahirizwa mu migenzo yose y'urubanza kugeza igihe icyemezo ndakuka gifatiwe. Iri hame riha uruhande rurega inshingano zo kuba arirwo rugaragaza ibimenyetso byemeza icyaha nta shiti, rikaba rireba inzego zose<sup>62</sup> (harimo n'Ubushinjacyaha).

Ntabwo intego y'Umushingamategeko ubwo yashyiragaho iyo ngingo kwari ukugira ngo Urwego rw'Ubugenzacyaha ruzajye rushakira abanyamakuru ababaha inkuru ku mikorere y'ibyaha. Niyo mpamvu ijamba amakuru rigomba guhuzwa n'amagambo yafasha mu iperereza" nayo agaragara muri iyo ngingo.

[116] Murangwa Edward n'abamwunganira bavuga ko amagambo "impamvu zifatika, ibimenyetso bifatika n'ibimenyetso bikomeye" ari mu ngingo ya 10, agace ka 3 a, b na c z'Itegeko N° 12/2017 ryo ku wa 07/04/2017 ryavuzwe haruguru yanditswe mu buryo bwa rusange ku buryo uyakoresha bimugora kumenya icyo avuze, ndetse akaba yarabaye urwitwazo ku nzego z'Ubugenzacyaha n'Ubushinjacyaha rwo gukora isaka nta rupapuro rw'isaka (*warrantless search*).
