[21] Ingingo ya 74, igika cya mbere n'icya kabiri, y'Itegeko N°30/2018 ryavuzwe haruguru iteganya kandi ko Iyo Urukiko rw'Ikirenga ruburanisha izindi manza zitari izo kuzengura ko itegeko ritanyuranyije n'Itegeko Nshinga, hakabonekamo ikibazo cy'itegeko rinyuranyije n'Itegeko Nshinga, rugomba kubanza kugikemura mbere yo kuburanisha urubanza mu mizi yarwo. Iyo icyo kibazo kigaragaye, gitanzwe n'ababuranyi cyangwa urukiko rubyibwirije, mu iburanisha ry'urubanza mu nkiko zo hasi, izo nkiko zihita zihagarika iburanisha ry'urubanza rw'ibanze, zikoherereza Urukiko rw'Ikirenga icyo kibazo kugira ngo rubanze rugifateho icyemezo.

[22] Nk’uko byibukijwe haruguru, ikibazo nyamukuru kiri muri uru rubanza impande zombi zirurimo zitumvikanaho, ni ukumenya niba itegeko ryavuyeho rishobora kuregerwa ko rinyuranyije n’Itegeko Nshinga, aho Intumwa za Leta zihamya ko bidashoboka, ariko uhagarariye Fast Truck Interior and Hardware Ltd we akavuga ko ntakibibuzwa mu gihe iryo tegeko ryakomeje gukoreshwa na nyuma y’uko rivuyeho ku bikorwa byabayeho rigikurikizwa.

[30] Urukiko rurebye ibisabwa mu itangwa ry’ibirego bisaba kwemeza ko itegeko rinyuranyije n’Itegeko Nshinga n’imihango iteganyijwe nyuma yo gusanga ariko bimeze, rurasanga ari imihango ya ngombwa ku buryo mu gihe itubahirijwe byatuma icyemezo Urukiko rwaba rwafashe gita agaciro, kuko Urukiko rw’Ikirenga rutamenyesha Inteko Ishinga Amategeko na Guverinoma kugira ngo hakurweho itegeko n’ubundi ritakiriho cyangwa ngo hatangazwe mu Igazeti ya Leta urubanza rwemeza ko itegeko rivuyeho kandi n’ubundi ryaramaze gutangazwa ko ryavanyweho. Ibyo binahura n’ibyavuzwe na Me Hategeka Placide mu iburanisha, aho yireguye avuga ko bitaba ngombwa kumenyesha Inteko Ishinga Amategeko kuko iryo tegeko ryavuyeho.

[31] Urukiko rurasanga ingaruka ziva mu kvanaho itegeko zaranasobanuwe mu rubanza “*The State of Manipur vs Surjakumar Okram*” rwaciwe n’Urukiko rw’Ikirenga rw’Ubuhande, rwavuzwe haruguru, mu gika cyarwo cya 15 ku rupapuro rwa 6, aho rwemeje koingaruka zo kvanaho itegeko ni ugusibwa burundu mu bitabo by’Inteko Ishinga Amategeko nk’aho ritigeze ritorwa kandi bigafatwa nk’aho ritigeze ribaho keretse irengayobora ku bikorwa byari byatangiyeye, ibyamaze gushinjwa ndetse n’ibyamaze gukorwa igihe ryari itegeko rikiriho. Rusobanura kandi ko [...] uwo ari umurongo wamaze kwemezwa mu mategeko ko igihe cyose itegeko rivanyweho, bigomba gufatwa nk’aho ritigeze ribaho. Ikigamijwe mu kurivanaho akaba aba ari ukurandura iryo tegeko keretse irengayobora ku mpamvu zimwe ziteganijwe. Kvanaho akaba atari ikibazo kirebana n’imiterere (*form*) gusa ahubwo kikaba kinareba ibirimo (*substance*). Bityo rero, iyo itegeko rivanyweho, ingingo zaryo ziba zakuweho mu buryo bwose.⁵
