

KAMUGWIZA v HASHIM

Amategeko mbonezamubano - Ubutumwa bwo kwivanaho umutungo - Umuntu wahawe ubutumwa rusange afite gusa ububasha bwo gukora ibikorwa bisanzwe byo gucunga umutungo no kuwungura, naho igikorwa gikomeye nk'icyo kugurisha cyangwa kwivanaho umutungo mu buryo ubwo aribwo bwose, gisaba ubutumwa bweruye bugaragariza uwabuhawe nibura umwirondoro w'umutungo ugomba kugurishwa; ni ukuvuga ko bugomba kugaragaza uwo mutungo mu buryo bugaragara kandi budataye urujijo.

Incamake y'ikibazo: Uru rubanza rwatangiriye mu Rukiko rwisumbuye rwa Gasabo Hashim arega Mukuralinda ko yamugurishirije ikibanza mu buryo bunyuranije n'amategeko aho avuga ko yamuhaye ububasha bwo kujya amugurira ibibanza akanamwubakira amazu ariko nyuma Mukuralinda aza kuvuga ko indangamuntu ye yatakaye bityo ko hakwiye gukorwa indi nyandiko mpushabubasha isimbura iya mbere, hanyuma iyo nyandiko iza gukorerwa imbere ya Noteri ariko hiyongeramo ijambo kugurisha bituma uwahawe ububasha agurisha ikibanza cya Hashim ntiyanamuha n'amafaranga akivuyemo. Urukiko rwisumbuye rwasanze Hashim atabasha gusobanura uko yatanze ububasha bwo kugurisha bituma atsindwa. Yaje kujurira mu Rukiko rw'Ubujurire, nyuma yo gusuzuma ubujurire bwe, rusanga bufite ishingiro ko amasezerano y'ubugure yakozwe ku wa 21/03/2015 ku butaka bubaruye kuri UPI 5/07/09/02/984, n'ibyangombwa by'ubukode burambye byanditswe kuri Kamugwiza byatanze ku wa 20/02/2015 no ku wa 13/07/2015 biteshejwe agaciro. Urwo rubanza nirwo Kamugwiza, uvuga ko yaguze ikibanza kiburanwa yajuririye mu Rukiko rw'Ubujurire ariko urwo rukiko rusanga ubujurire bwe nta shingiro bufite, noneho bituma atanga ikirego gisubirishamo urubanza ku mpamvu z'akarengane.

Mu iburanisha mu Rukiko rw'Ikirenga, Kamugwiza asobanura ko akarengane ke gashingiye ku kuba Urukiko rubanza rutarahaye agaciro inyandiko itanga ububasha burimo no kugurisha bigatuma rutesha agaciro amasezerano y'ubugure bw'ikibanza nyamara mu rwego rw'amategeko ntahagaragajwe inenge ayo masezerano y'ubugure afite kuko yakozwe n'abantu babifitiye ububasha. Hashim we avuga ko atigeze atanga ububasha bwo kugurisha ko icyabaye ari uko bamusomeye inyandiko, itanga ububasha bwo kugura no kumwubakira amazu gusa hanyuma bakamusinyisha ku nyandiko ebyiri bamubwira ko zombi zisa iya kabiri ikaba ariyo yari yongewemo ijambo kugurisha. Yasobanuye kandi ko yizeraga Mukuralinda kuko bakuranye hanyuma we akaza kugira ikibazo cyo kutabona neza bitewe n'uburwayi bituma amuha ububasha bwavuzwe hejuru.

Urubanza

I. INCAMAKE Y'URUBANZA

1. Uru rubanza rwatangijwe na Sakina HASHIM mu Rukiko Rwisumbuye rwa Gasabo avuga ko Mukuralinda Alain Bernard yamugurishirije ikibanza mu buryo bunyuranyije n'amategeko. Yasobanuye ko ku wa 15/01/2009 yamuhaye procuration kugira ngo aje amugurira ibibanza anamwubakire amazu, bigeze mu mwaka wa 2014, Mukuralinda Alain Bernard amubwira ko irangamuntu yari yanditswe muri iyo procuration yatakaye, akaba akeneye indi procuration igaragaza irangamuntu nshya. Avuga ko bajyanye kwa Noteri ku wa 09/05/2014, bamusomera procuration isa n'iya mbere ariko bamutege indi irimo ijamba "kugurisha", ayisinya atabizi, iyo bamuteze aba ariyo ishingirwaho hagurishwa ikibanza cye, n'amafaranga yavuyemo ntiyayahabwa.

2. Urwo Rukiko rwasanze Sakina Hashim atavuga ko atahaye Mukuralinda Alain Bernard ububasha bwo kumugurishiriza ikibanza kandi barajyanye kwa noteri ari muzima, nta n'agahato yashyizweho akamusinyira procuration yo ku wa 09/05/2014. Ibi byatumye Sakina Hashim ajuririra Urukiko Rukuru, nyuma yo gusuzuma ubujurire bwe, rusanga bufite ishingiro. Urwo rubanza nirwo Kamugwiza Phoebe, uvuga ko yaguze ikibanza kiburanwa yajuririye mu Rukiko rw'Ubujurire ariko urwo Rukiko rusanga ubujurire nta shingiro bufite, noneho bituma atanga ikirego gisubirishamo urubanza ku mpamvu z'akarengane.

3. Nyuma yo gusanga Mukuralinda Alain Bernard yarashingiye ku butumwa rusange agurisha umutungo wa Sakina Hashim, Uru Rukiko rusanga:

i. Umuntu wahawe ubutumwa (mandat) rusange afite gusa ububasha bwo gukora ibikorwa bisanzwe byo gucunga umutungo no kuwagura; naho ibikorwa bikomeye nk'icyo kugurisha kivugwa muri uru rubanza, bisaba ubutumwa bweruye bugaragariza uwabuhawe nibura umwirondoro w'umutungo ugomba kugurishwa;

ii. Procuration yanditswe mu buryo rusange ikwiye gufatwa nk'igamije gucunga umutungo mu rwego rwo kurengera uwayitanze kuko bitashoboka ko umuntu ukiriho, ufite ubushobozi n'ububasha atanga uburenganzira bw'uko imitungo yose afite n'iyi azagira igurishwa n'undi;

iii. Ubutumwa bwo kwivanaho umutungo mu buryo ubwo aribwo bwose bugomba kuba butari rusange, bugomba kugaragaza uwo mutungo mu buryo bugaragara kandi budateye urujijo. Nyuma y'ibyo bisobanuro, Urukiko rwanzuye ko, harebwe imiterere ya procuration yashingiweho, Mukuralinda Alain Bernard nta bubasha bwo kugurisha imitungo ya Sakina Hashim yari afite.

II. IMITERERE Y'URUBANZA.

[1] Uru rubanza rwatangiriye mu Rukiko Rwisumbuye rwa Gasabo, Sakina Hashim arega Kamugwiza Phoebe kuba yaragiranye amasezerano y'ubugure ya baringa na Mukuralinda Alain Bernard, uyu akagurisha ikibanza cye kibaruye kuri UPI 5/07/09/02/984, gihereye mu Karere ka Bugesera, Umurenge wa Ntarama, Akagali ka Kanzenze, Umudugudu wa Kabeza yitwaje ko atumwe na Sakina Hashim kukimugurishiriza, nyamara nta burenganzira bwo kugurisha, kwakira amafaranga cyangwa ubwo guhinduza ibyangombwa mu izina rye yatanze, asaba Urukiko kwemeza ko ibyakozwe na Mukuralinda Alain Bernard byo kugurisha mu izina rye icyo kibanza nta kuri kurimo, bityo ko nta n'amasezerano y'ubugure yabayeho.

[2] Kamugwiza Phoebe yireguye avuga ko amasezerano y'ubugure yabayeho, ko icyo kibanza yakiguze 45.000.000 Frw, yishyura Mukuralinda Alain Bernard wari uhagarariye Sakina Hashim

kuko uyu yari yaramuhaye procuration, asaba Urukiko kudaha ishingiro ikirego cya Sakina Hashim ahubwo rukemeza ko amasezerano y'ubugure yakozwe mu buryo bukurikije amategeko kuko ntawigeze ayatesha agaciro cyangwa ngo ayatambamire.

[3] Mu nama ntegururubanza, ababuranyi basabye ko Famida Hashim na Mukuralinda Alain Bernard bagobokeshwa mu rubanza. Mu gihe cy'iburanisha, Urukiko rwasanze nta kigaragaza ko Mukuralinda Alain Bernard yamenyeshejwe iby'uko afite urubanza ndetse n'ibyavugwaga na Me Nizeyimana Boniface by'uko amuhagarariye, atabyemererwa kuko ari we uburanira Kamugwiza Phoebe wasabye ko Mukuralinda Alain Bernard agobokeshwa, ruvuga ko Mukuralinda Alain Bernard adakwiye gufatwa nk'umuburanyi mu rubanza.

[4] Ku bijyanye n'imizi y'ikirego, urubanza no RC 00303/2016/TGI/GSBO rwaciwe ku wa 29/06/2017, Urukiko rusanga inyandiko y'impeshabubasha (procuration) Mukuralinda Alain Bernard yahawe na Sakina Hashim nta nenge ifite kuko yakorewe imbere ya Noteri, Sakina Hashim ayisinyaho, akuze, ari muzima kandi nta gahato yashyizweho, byumvikanisha ko Mukuralinda Alain Bernard yari afite ububasha bwo kugurisha imitungo ya Sakina Hashim mu gihe abona ari ngombwa, rwanzura ko amasezerano y'ubugure atagomba guteshwa agaciro. Naho ku bijyanye n'indishyi zasabwaga n'abaregwa, Urukiko rwasanze zifite ishingiro, rutegeka Sakina Hashim guha Kamugwiza Phoebe na Famida Hashim, kuri buri wese, indishyi zingana na 1.300.000 Frw y'igihembo cya Avoka n'amafaranga y'ikurikiranarubanza.

[5] Sakina Hashim yajuririye Urukiko Rukuru avuga ko Kamugwiza Phoebe atari kugura ikibanza ku wa 21/03/2015 kandi bigaragara ko yari yaragihereye icyangombwa cy'ubukode burambye ku wa 20/02/2015, ndetse ko na nyuma yaho, ku wa 13/07/2015 yongeye guhabwa ikindi cyangombwa kuri uwo mutungo, bikaba bitumvikana uburyo yari guhabwa ibyangombwa bibiri ku mutungo umwe. Yavuze kandi ko nawe yari yarahawe icyangombwa cy'ubukode burambye kuri uwo mutungo ku wa 20/02/2015, bivuze ko kuri iyo tariki hatanzwe ibyangombwa bibiri, bihabwa abantu batandukanye ku mutungo umwe, ibyo bikaba bitera urujijo, asaba kurenganurwa agasubizwa ikibanza cye Mukuralinda Alain Bernard yagurishije atabimuhereye uburenganzira.

[6] Mu iburanisha ryabaye ku wa 19/04/2018, ababuranyi basabye ko Mukuralinda Alain Bernard agobokeshwa mu bujurire ariko ntagire ibyo acibwa. Urukiko rwasanze ubwo busabe bufite ishingiro, rutegeka ko Mukuralinda Alain Bernard agobokeshwa, akaba umuburanyi mu rubanza.

[7] Mu rubanza no RCA 00265/2017/HC/KIG rwaciwe ku wa 09/11/2018, Urukiko rwanzuye ko ubujurire bwa Sakina Hashim bufite ishingiro, ko amasezerano y'ubugure yakozwe ku wa 21/03/2015 ku butaka bubaruye kuri UPI 5/07/09/02/984, n'ibyangombwa by'ubukode burambye byanditswe kuri Kamugwiza Phoebe byatanzwe ku wa 20/02/2015 no ku wa 13/07/2015 biteshejwe agaciro. Mu gufata icyemezo, Urukiko rwasanze:

- i. Ikigo gishinzwe imicungire y'ubutaka mu Rwanda kivuga ko ku bijyanye n'ikibanza kibaruye kuri UPI 5/07/09/02/984, nta byangombwa bibiri byatanzwe ku wa 20/02/2015 kuko hatanzwe icya Sakina Hashim gusa, rusanga nubwo Kamugwiza Phoebe afite amasezerano y'ubukode burambye yo ku wa 20/02/2015 n'ayo ku wa 13/07/2015, atabasha kugaragaza ibyangombwa yahawe n'uwamugurishije n'igihe yakorewe iherekanyamutungo;

- ii. Sakina Hashim atari kuba yagurishije Kamugwiza Phoebe uwo mutungo ngo agumane icyangombwa cyawo cy'umwimerere;
- iii. Bitumvikana uburyo Mukuralinda Alain Bernard yari kwishyurwa 45.000.000 Frw, yajya kuyaha nyirayo akayatanga mu ntoki.

[8] Nyuma yo gukoresha igenagaciro ry'umutungo uburanwa ryagaragaje ko ufite agaciro ka 182.165.000 Frw, Kamugwiza Phoebe yajuririye Urukiko rw'Ubujurire avuga ko Urukiko Rukuru rutagombaga gutesha agaciro amasezerano y'ubugure yo ku wa 21/03/2015, kuko yakozwe mu buryo bwemewe n'amategeko, kubera ko mu burenganzira Sakina Hashim yari yarahaye Mukuralinda Alain Bernard harimo n'ubwo kugurisha imitungo ye.

[9] Sakina Hashim yatanze inzitizi y'iburabubasha, avuga ko agaciro k'ikiburanwa katageze kuri 75.000.000 Frw ziteganywa n'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'inkiko kuko haburanwa gutesha agaciro amasezerano y'ubugure bw'ubutaka bwaguzwe 45.000.000 Frw, agaciro ka 182.165.000 Frw kavugwa muri raporo y'igenagaciro yatanzwe n'uwajuriye kakaba katashingirwaho kuko ntaho kagaragara mu masezerano y'ubugure kandi kakaba kataragiweho impaka kuva urubanza rugitangira.

[11] Naho ku wa 06/05/2020, Urukiko rwaciye urubanza mu mizi ku kibazo cyo kumenya niba amasezerano y'ubugure hagati ya Kamugwiza Phoebe na Mukuralinda Alain Bernard akwiye guteshwa agaciro, rusanga Urukiko Rukuru rwari rufite ukuri ubwo rwemezaga ko ayo masezerano ateshwa agaciro. Urukiko rw'Ubujurire rwageze kuri uwo mwanzuro rushingiye ku mpamvu zikurikira:

- i. Kuba ubutaka bubaruye kuri UPI 5/07/09/02/984 bwaranditswe kuri Kamugwiza Phoebe ku wa 20/02/2015, ariko amasezerano y'ubugure na Sakina Hashim akandikwa ko yakozwe ku wa 21/03/2015, bikaba bidashoboka ko yagura ubutaka busanzwe bumwanditsweho;

Kuba procurations Mukuralinda Alain Bernard ashingiraho avuga ko zamuhaga ububasha bwo kugurisha uwo mutungo mu izina rya Sakina Hashim zigaragaza ko zitandukanye, iyo ku wa 15/01/2009 ikaba imuha ububasha bwo kugurira Sakina Hashim ubutaka no kumwubakira inzu, naho iyo ku wa 09/05/2014 ikamuha uburenganzira busesuye harimo n'ubwo kugurisha, kuba izo procurations zombi zarakorewe imbere ya Noteri umunsi umwe wo ku wa 09/05/2014 bikaba bigaragaza ko zakozwe mu buriganya;

- iv. Kuba nta hererekanya ry'ubutaka ryabayeho hagati ya Kamugwiza Phoebe na Sakina Hashim kuko uyu agifite icyangombwa cy'ubwo butaka, nyamara mu ngingo ya 4 n'iyi 5 z'amasezerano y'ubugure yo ku wa 21/03/2015, Mukuralinda Alain Bernard wari uhagarariye Sakina Hashim akaba yaravuze ko ahaye Kamugwiza Phoebe ibyangombwa by'ubutaka aguze, ko kuba inyandiko z'umwimerere zari zikibitswe na Sakina Hashim ari ikimenyetso cy'uko uyu atigeze abugurisha.

[12] Kamugwiza Phoebe yandikiye Perezida w'Urukiko rw'Ikirenga asaba ko urubanza no RCAA 00001/2019/CA rwaciwe n'Urukiko rw'Ubujurire ku wa 06/05/2020, rusubirishwamo ku mpamvu z'akarengane. Mu cyemezo N° 057/CJ/2020 cyo ku wa 16/11/2020, Perezida w'Urukiko rw'Ikirenga amaze gusuzuma ubwo busabe, yemeje ko rwoherezwa mu Bwanditsi bw'Urukiko rw'Ikirenga kugira ngo ruzongere ruburanishwe.

[13] Urubanza rwaburanishijwe mu ruhame ku wa 12/10/2021, Kamugwiza Phoebe ahagarariwe na Me Nizeyimana Boniface, Sakina Hashim ahagarariwe na Me Nsabimana Jean-Baptiste, Mukuralinda Alain Bernard ahagarariwe na Me Niyitegeka Eraste naho Famida Hashim ahagarariwe na Me Nsabayezu Evariste, haherwa ku kibazo cyazamuwe na Me Nsabimana Jean-Baptiste wasabye ko hasuzumwa niba Urukiko rw'Ubujurire rwari rufite ububasha bwo kuburanisha ubujurire bwa kabiri bwa Kamugwiza Phoebe. Ku wa 29/10/2021, Urukiko rwaciye urubanza rubanziriza urundi, rusanga umuburanyi utarasabye ko urubanza rusubirishwamo ku mpamvu z'akarengane, atakwuririra ku kirego cyatanzwe n'uwo baburana, ngo nawe asabe Urukiko gusuzuma ibyo atishimiye muri urwo rubanza, rwanzura ko inzitizi y'iburabubasha bw'Urukiko rw'Ubujurire yatanzwe muri urwo rukiko itakongera gusuzumwa muri uru rubanza.

[15] Mu gihe ariko Urukiko rwari rwiherereye ngo ruce urubanza, rwasanze ari ngombwa guhamagaza bamwe mu baburanyi kugira ngo rubone amakuru ahagije ku bimenyetso biri muri dosiye bitavugwaho rumwe. Rushingiye ku biteganywa n'ingingo ya 60 y'Itegeko no 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iteganya ko Urukiko rushobora gutegeka ko ababuranyi barwitaba ubwabo, Urukiko rwemeje ko Sakina Hashim, Mukuralinda Alain Bernard na Famida Hashim barwitaba ubwabo.

[38] Iyo procuration abaturanyi ntibayemeranywaho kuko Mukuralinda Alain Bernard avuga ko Sakina Hashim yayimuhaye mu buryo bukurikije amategeko kandi ko yamuhaga ububasha bwo kugurisha ikibanza kiburanwa, naho Sakina Hashim akavugaga ko Mukuralinda Alain Bernard yayimusinyishije mu buriganya, ayisinya atazi ko bamuteze ijamba "kugurisha", bityo ko n'ubugure bushingiye kuri iyo procuration nta gaciro bufite. icyakora, mbere yo gusuzuma niba uburiganya buvugwa na Sakina Hashim bwarabayeho cyangwa butarabayeho, ni ngombwa gusuzuma niba imiterere ya procuration yahawe Mukuralinda Alain Bernard ituma afatwa nk'wahawe ububasha bwo kugurisha ikibanza cya Sakina Hashim.

S'il s'agit d'aliéner ou hypothéquer ou de quelque autre acte de propriété, le mandat doit être exprès".
