Amategeko agenga ubutaka – Ihererekanya ry'umutungo utimukanwa – Kugirango umutungo utimukanwa uve ku wo wari uraho ujye ku wundi, hagomba kubaho amasezerano akorewe imbere ya Noteri w'ubutaka akaba ariyo akomokaho icyemezo cy'iyandikisha cyemeza nyir'umutungo.

Incamake y'ikibazo: Byuma Jean Claude yeguriwe na Sosiyete SOPROCOGI Ltd yari abereye Visi Perezida wayo, umutungo wayo urimo ahari hateganyirije ububiko bwayo (*stock*) hafite ikirango cya “O” ndetse na $\frac{1}{4}$ cy’inzu yitwa ingarigari ya sosiyete ifite ikirango cya “I” bigizwemo uruhare n’abanyamigabane bateraniye mu nama, ariko $\frac{1}{4}$ cy’inzu yitwa ingarigari ya sosiyete ifite ikirango cya “I” cyiza kugurishwa na Rudasingwa Jean-Baptiste (Perezida w’iyo sosiyete) na Mungwarareba Jean Bosco (Umubitsi wayo) bagurishije BH TRADERS Ltd, ibyo bituma Byuma atanga ikirego mu Rukiko rw’Ubucuruzi asaba ko ayo masezerano y’ubugure aseswa kuko yakozwe ku buryo bunyuranyije n’amategeko, ahubwo we akandikwaho iyo mitungo yahawe.

Urukiko Rukuru rw’Ubucuruzi mu rubanza CMB RCOMA 00316/2017/CHC/HCC rwemeje ko ibimenyetso bidahagije mu kwemeza ko SOPROCOGI Ltd yari ifite ububasha busesuye bwo kugurisha umutungo wari waramaze kwegurirwa Byuma, rutegeka kandi ko umutungo Byuma yagurishije Koperative Icyerekezo cy’Iterambere ariyo igomba kuwandikwaho.

Urukiko rw’Ubujurire rwemeje ko amasezerano y’ubugure yabaye hagati ya BH TRADERS Ltd na SOPROCOGI Ltd yubahirije amategeko, rutegeka ko urubanza rwajuririwe ruhindutse uretse gusa ku byo Koperative Icyerekezo cy’Iterambere yatsindiye Byuma.

Byuma yandikiye Perezida w’Urukiko rw’Ikirenga asaba ko urubanza RCOMAA 00046/2018/CA rwaciwe n’Urukiko rw’Ubujurire rusubirwamo ku mpamvu z’akarengane.

Perezida w'Urukiko rw'Ikirenga amaze gusuzuma ubwo busabe, yemeje ko rwoherezwa mu Bwanditsi bw'Urukiko rw'Ikirenga kugira ngo ruzongere ruburanishwe.
