Bavuga ko iba yishingiwe n'umuganga wayishyizeho umukono, kandi ishobora kugibwaho impaka n'uwo igenewe (*l'employeur*) cyangwa abandi baganga⁶.

[24] Aba bahanga kandi bagaragaza ko igomba gutangwa guhera ku munsi wa mbere w'ikiruhuko n'ubwo hari abenshi bayitanga mu minsi 3 cyangwa⁴. Mu rubanza *Mgobhozi v Naidoo NO & others [2006] 3 BLLR 242 (LAC)* Urukiko rw'Ubujurure rw'Umurimo muri Afurika y'Epfo rwemeje ko *repos médical (medical certificate)* ari nk'impamvu gusa (*hearsay*) igihe cyose idashygikiwe n'ikindi kimenyetso kibishimangira, nkiko zikaba zigomba kuzitondera kugira ngo zirinde ikoreshwu nabi ryazo⁷. Ni nako Urukiko rwabivuze mu rubanza rwa *Sipho Emmanuel Mgobhozi na Rajah Naidoo Arbitrator, Durban Metropolitan Bargaining Council na Durban Metropolitan Council (Housing)*⁹. Ibyo izi nkiko zemeje n'ibyo abahanga bavuga bigaragaza ko gutanga *repos médical* nk'ikimenyetso bigomba gukorwa vuba bishoboka (*as soon as possible*), kandi ko ubwabyo bidahagije kugira ngo ifatwe nk'ukuri cyangwa idakoreshejwe mu buryo butari bwo.

[25] Hashingiwe ku bimaze kuvugwa, nta kibuza Urukiko gusuzuma niba *repos médical* itanzwe mu rukiko ikwiye kwemerwa nk'impamvu idasanzwe kandi ikomeye ibuza umuburanyi kwitabira iburanisha yatumijwemo mu buryo bwubahirije amategeko, kugira ngo yemeze ko koko iyo mpamvu ari yo, idasanzwe kandi ikomeye, nk'uko biteganywa n'ingingo ya 55 y'Itegeko N° 22/2018 ryo kuwa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi. Ibi bivuze rero ko Umucamanza aramutse asanze iyo *repos medical* ishobora gukemangwa afite ububasha bwo kutayiha agaciro igihe idashimangiwe n'ikindi kimenyetso.

[26] Urukiko rurasanga umuburanyi utari bushobore kwitabira iburanisha ku mpamvu iyo ari yo yose ashobora kubimenyesha Urukiko mu buryo butandukanye harimo ubu bukurikira kugira ngo ruyisuzume :

- a. Kuba yakwandika ubutumwa muri IECMS abimenyesha Urukiko mbere urubanza rutaraba anatanga ikimenyetso kibigaragaza ;
- b. Kuba uwo ahagarariye cyangwa yunganira ykwitabira iburanisha akamenyesha Urukiko ko umwunganira cyangwa umuburanira yarwaye cyangwa yagize indi mpamvu ikomeye yamubujije kwitabira iburanisha ;
- c. Kuba yakwihutira (*as soon as possible*) kubimenyesha Urukiko aho abishoboreye binyuze muri IECMS akanatanga ikimenyetso kibigaragaza.

[27] Urukiko rurasanga kudatangira igihe *repos médical* cyangwa ikindi kimenyetso kigaragaza impamvu umuburanyi atari bwitabire cyangwa atitabiriye iburanisha yahamagajwemo mu buryo bwubahirije amategeko bigaragaza umwete mucye, kudaha agaciro urubanza cyangwa kutubaha Urukiko, kandi bigaha icyuho ikoreshwa ry'inyandiko zitavuga ukuri, ibi bikaba bigira ingaruka zikomeye mu mitangire y'ubutabera, ndetse binakurura ibyaha byo gukoresha nyandiko mpimbano, hatangwa inyandiko zitavuga ukuri (nka *certificat de complaisance*⁸). Ni ngombwa rero ko umuburanyi yihutira kumenyesha urukiko muri bumwe mu buryo bwagaragajwe haruguru, kugira ngo Umucamanza ashobore kubisuzuma no kubifataho umwanzuro ukwiye.

[28] Mu gusuzuma icyatumye Nambajimana Jean Baptiste atitabira iburanisha ndetse ntanabimenyeshe urukiko hagaragaye ibi bikurikira :

[29] Urukiko rurasanga kuba Me Nambajimana Jean Baptiste yarashoboye kugira ibyo akora mu zindi manza mu gihe avuga ko yari mu kiruhuko cy'uburwayi, bigaragaza ko yashoboraga no koherereza Urukiko Rukuru rw'Ubucuruzi *repos médical* na *ordonnance*, akarumenyesha impamvu atashoboye kwitabira iburanisha, kandi akabikora nibura igihe yatangiriye kwita ku zindi manza nk'uko byagaragajwe, kuko biboneka ko yari afite imbaraga zo kwandika muri IECMS.

[30] Urukiko rurasanga kuba Me Nambajimana Jean Baptiste ataramenyesheje Urukiko ku gihe ko atari bushobore cyangwa atashoboye kwitabira iburanisha ngo anatange ikibyerekana, akaba atarashoboye gusobanura impamvu hari ibikorwa yakoze ku wa 10/08/2020 kandi avuga ko atashoboraga kugira icyo akora kuko yari arembye afite *repos médical* nk'uko yabivuze mu iburanisha, bigaragaza ko atakoreshsheje umwete (*diligence*)

[32] Nyuma yo gusanga ikirego kitaragombaga kwakirwa, Urukiko rurasanga ingingo ya 2 ijjanye no kumenya niba abishingizi bavugwa mu masezerano y'umwenda yabaye hagati ya Sacco Ifumba y'ubukire n'itsinda Inzira y'umurimo bategekwa kwishyura 3.486.930 Frw, bitakiri ngombwa ko isuzumwa.
