Amategeko agenga imanza z'i mbonezamubano – Impanuka yatewe n'ikinyabiziga – Ubuzime – Kuregera indishyi ku mwana udafite imyaka y'ubukure – Igihe ubuzime butangirira kubarwa - Umwana wakoze impanuka udafite ababyeyi cyangwa umwishingizi wo kumukurikiranira indishyi, igihe cy'ubuzime gihagarara kubarwa; cyongera gutangira kubarwa uherye igihe yuzuriye imyaka y'ubukure

Incamake y'ikibazo: Uru rubanza rwatangiriye mu Rukiko Rwisumbuye rwa Nyarugenge, Uwizeyimana, wakomerekeye mu mpanuka y'imodoka yishingiwe na SONARWA General Insurance Company Ltd (SONARWA) agacika akaboko, ayirega asaba ko itegukwa kumuha indishyi zinyuranye zikomoka kuri iyo mpanuka. Uregwa yatanze inzitizi yo kutakira icyo kirego avuga ko urega yarengeje igihe cy'imyaka itanu (5) iteganywa n'amategeko ku bijyanye no kuregera indishyi zikomoka ku mpanuka. Urwo Rukiko rwasanze ikirego kigomba kwakirwa, rutegeka SONARWA guha Uwizeyimana indishyiz'imbangamiraburanga, iz'imbonezamubano, iz'akababaro, izo gutakaza amahirwe yo gushaka n'amafaranga y'ibyakoreshejwe.

Uregwa yajuririye urwo rubanza mu Rukiko Rukuru, nuko rushingiye ku kuba n'ubwo Nyirasimpunga yaratoraguye Uwizeyimana, atigeze amugira umwana ku buryo yari kumukurikiranira indishyi zikomoka ku mpanuka no kuba yaritabye Imana nyuma y'imyaka ibiri impanuka ibaye, nyuma agakomeza kurerwa n'abaturanyi, rusanga kuba yararengeje imyaka itanu ataratanga ikirego, ubwo busaze budakwiye kubarwa kuko yari akiri umwana kandi nta babyeyi cyangwa abishingizi yari afite.

SONARWA yasabye ko urwo rubanza rusubirwamo, hamezwa ko ruburanishwa n'Urukiko rw'Ikirenga hasuzumwa ikibazo cyo kumenya niba harabayeho ubuzime bwo gusaba indishyi zikomoka ku mpanuka yo mu muhanda. SONARWA isobanura ko ikirego cya Uwizeyimana kitagombaga kwakirwa kuko atubahirije igihe cy'imyaka itanu (5) yo gukurikiranira indishyi zikomoka ku mpanuka akaba yaragitanze nyuma y'imyaka cumi n'umwe (11) impanuka ibaye, kandi ko Leta yakabaye yarakimukurikiraniye nk'umwana utari ufite umurera. Uwizeyimana we avuga ko ikirego cyagombaga kwakirwa hashingiwe ku kuba nk'umwana udafite ababyeyi, yaragitanze amaze kuzuzwa imyaka y'ubukure.

[1] Tarike ya 27/01/2006 Uwizeyimana Clarisse wari ufite imyaka umunani (8) y'amavuko yagonzwe n'imodoka Toyota Hilux RDF 331 D yari ifite ubwishingizi muri SONARWA General Insurance Company Ltd, acika ukuboko kw'ibumoso.

[2] Nyuma yo kuzuzwa imyaka y'ubukure, Uwizeyimana Clarisse yandikiye SONARWA General Insurance Company Ltd ku wa 25/09/2017, ayisaba indishyi zikomoka kuri iyo mpanuka, yongeraga kuyandikira ku wa 22/08/2018 ayihanangiriza ariko ntiyamubwira, maze atanga ikirego mu Rukiko Rwisumbuye rwa Nyarugenge ku wa 26/09/2018 arusaba kuyitegeka kumuha indishyi zitandukanye zikomoka kuri iyo mpanuka.

[3] SONARWA General Insurance Company Ltd yatanze inzitizi yo kutakira icyo kirego ivuga ko Uwizeyimana Clarisse yarengeje igihe cy'imyaka itanu (5) iteganywa n'amategeko ku bijyanye no kuregera indishyi zikomoka ku mpanuka. Me Gabiro David wamuburaniraga yireguye kuri iyo nzitizi, avugaga ko nta shingiro ifite kuko Uwizeyimana Clarisse yatangiye gukurikirana indishyi amaze kuzuzwa imyaka y'ubukure kubera ko nta babyeyi agira, akaba yari yaratoraguwe n'umukecuru witwa Nyirasimpunga Laurence badafite icyo bapfana akiri uruhinja, nyuma nawe akaza gupfa, akarerwa n'abaturanyi, kandi akaba yarakoze impanuka afite imyaka umunani (8) ku buryo atari yemerewe gukurikirana indishyi.

[8] Urubanza rwaburanishijwe mu ruhamwe ku wa 23/05/2023, SONARWA General Insurance Ltd ihagarariwe na Me Bimenyimana Eric naho Uwizeyimana Clarisse ahagarariwe na Me Gabiro David, abaturanyi bajya impaka ku bibazo byo kumenya niba harabaye ubuzime bwo gukurikirana ikirego cy'indishyi no kumenya niba hari indishyi SONARWA General Insurance Company Ltd igomba gusubizwa, naho ikibazo kirebana no kumenya niba ubumuga bwagaragaye kuri Uwizeyimana Clarisse bwaturutse ku mpanuka, uhagarariye SONARWA General Insurance Company Ltd yemereye mu iburanisha ko kitigeze kiburanwaho mu manza zabanje, kikaba rero kitasuzumwa bwa mbere ku rwego rw'akarengane nk'uko byatanzweho umurongo mu manza zitandukanye.¹ Iburanisha risojwe, abaturanyi bamenyeshejwe ko urubanza ruzasomwa ku wa 23/06/2023.

[9] Me Bimenyimana Eric uhagarariye SONARWA General Insurance Company Ltd avuga ko ikirego kitagombaga kwakirwa ngo gisuzumwe kuko nk'uko bigaragazwa n'inyandikomvugo yakozwe n'urwego rubifitiye ububasha, impanuka yabaye ku wa 27/01/2006, Uwizeyimana Clarisse ayimenyeshya umwishingizi bwa mbere ku wa 25/09/2017, ni ukuvuga hashize imyaka irenga 11, ibyo bikaba binyuranije n'ingingo ya 4 y'Itegeko N° 01/2002 ryo ku wa 17/01/2002 rihindura kandi rikuzuzura Itegeko N° 20/75 ryo ku wa 20/06/1975 rirebana n'ubwishingizi muri rusange.²

[10] Akomeza asobanura ko Itegeko N° 01/2002 ryavuzwe haruguru riteganywa ko impanuka igomba kumenyekanishwa mu myaka itanu (5) kuva ibaye, bitaba ibyo, iryo menyekanisha ntrigire agaciro. Ku bw'ibyo, akaba asanga Urukiko rutaragombaga guha agaciro imenyekanisha ryakozwe na Uwizeyimana Clarisse kuko yarengeje ibihe biteganywa n'amategeko, bityo akaba adashobora no gusaba indishyi.

[11] Avuga kandi ko PV de synthèse d'accident de roulage igaragaza ko abarega (plaignants) ari Ubushinjacyaha (Ministère Public) na Nyirasimpunga Laurence, inzego z'ibanze zikaba zaremeje ko Nyirasimpunga Laurence ariwe watoraguye Uwizeyimana Clarisse, akaba ari nawe wari umutunze icyo gihe, bikumvikana ko kuba yarabonye ubushobozi bwo kumuhagararira mu Bugenzacyaha, yaragombaga no kumuhagararira mu kumenyekanisha impanuka no gusaba indishyi. Ariko ko n'iyi Nyirasimpunga Laurence atari kubikora, abatangabuhamya babonye iby'iyi mpanuka cyangwa abaturanyi bamusigaranye nabo bari bafite ububasha bwo gukurikiranira Uwizeyimana Clarisse icyo kibazo.

[12] Avuga ko Urukiko Rwisumbuye rutagomba kwakira ikirego cya Uwizeyimana Clarisse, ahubwo ko uyu yari kwiyambaza izindi nzira kugira ngo arenganurwe hashingiwe ku biteganywa n'ingingo ya 128 y' Igitabo cya mbere cy'Urwunge rw'amategeko mbonezamubano ryakurikizwaga impanuka ikorwa. Asobanura ko Uwizeyimana Clarisse yashoboraga gukurikirana uburenganzira bwe ku ndishyi yifashishije Conseil de Tutelle, cyangwa agasaba Leta kuzikurikirana kubera ko ariyo ireberera abana badafite kirengera. Agaragaza ko ibihe by'ubuzime byashoboraga guhagarara gusa mu gihe bari gushobora kugaragaza ko batangiye gusaba ko habaho ubwumvikane.

[13] Me Gabiro David uhagarariye Uwizeyimana Clarisse avuga ko asanga SONARWA General Insurance Company Ltd yitiranywa umuhango wo kumenyeshya impanuka, n'uwu gukurikirana indishyi zikomoka ku mpanuka. Asobanura ko umuhango wo kumenyekanisha impanuka utarebaga Uwizeyimana Clarisse kuko ukorwa na nyir'ikinyabiziga kiba cyateje iyo mpanuka, ahubwo ko yarebwaga no gukurikirana indishyi zikomoka ku mpanuka yatejwe n'ikinyabiziga cyari cyishingiwe na SONARWA General Insurance Company Ltd. bitewe n'uko yari akiri umwana (mineur civil), amategeko atamwemereraga kwikurikiranira indishyi, ko ubundi byari gukorwa n'ababyeyi be iyo aba abazi, kandi nk'uko byasobanuwe mu manza zabanje, yatoraguwe ari uruhinja.

[14] Akomeza avuga ko uwitwa Nyiransimpunga Laurence wari waramutoraguye nawe nta bubasha yari afite bwo gukurikirana izi ndishyi kuko atari umwishingizi we (tuteur) cyangwa ngo abe yaremeye kumwiyandikishaho nk'umuntu umurera mu buryo bwemewe n'amategeko, na nyuma y'uko yitabye Imana, abasigaye barera Uwizeyimana Clarisse nabo batari bafite ububasha bwo kuregera indishyi kuko batigeze bamwiyandikishaho nk'uko amategeko abiteganyaga. Izo akaba arizo mpamvu zatumye Uwizeyimana Clarisse ategereza ko abanza kuzuza imyaka y'ubukure kugira ngo yitangire ikirego.

[15] Avuga kandi ko n'ubwo SONARWA General Insurance Ltd ivuga ko ikirego cya Uwizeyimana Clarisse kitagombaga kwakirwa, ishingiyeye ku gihe cy'imyaka 5 cyo kuba uwahohotewe yamenyekanishije impanuka asaba indishyi giteganywa n'ingingo ya 4 y'Itegeko n° 01/2002 ryo ku wa 17/01/2002 rihindura rikanuzuzwa Itegeko-Teka n°20/75 ryo ku wa 20/06/1975 rirebana n'ubwishingizi muri rusange, iteganyaga ibijyanye n'ibihe by'imyaka 5 yo kuregera indishyi zikomoka ku mpanuka, yirengagiza ko ingingo ya 10, igika cya 2 n'icya 3 n'ingingo ya 11 y'Itegeko –Teka n° 32/75 ryo ku wa 7/8/1975 rijyanye n'ubwishingire buturutse ku buryozwe butewe n'ibigenzwa ku butaka bifite moteri, yateganyije irengayobora ku birebana n'ibyo bihe.

[16] Asoza avuga ko kuba mu manza zabanje, inkiko zaragaragaje icyo zashingiyeho mu gufata ibyemezo nko mu rubanza N° RC 00847/2018/TGI/NYGE mu gika cya 11 no mu rubanza N° RCA 00289/2019/HC/KIG mu bika cya 13, 14, 15 na 16, aho Urukiko Rukuru rwagaragaje ibitekerezo by'abahanga ku birebana n'ubusaze ndetse runasesengura neza ingingo ya 3 y'Itegeko Teka N° 32/1975 ryo ku wa 7/8/1975 ryerekeye ubwishingire butegetswe n'ibigenzwa ku butaka bifite moteri, asanga nta karengane kagaragara mu mikirize y'urubanza N° RCA 00289/2019/HC/KIG, ahubwo ko ari ukutanyurwa n'icyemezo cyafashwe n'Urukiko.

UKO URUKIKO RUBIBONA

[17] Ingingo ya 10, mu gika cyayo cya 1, y'Itegeko-Teka N° 32/1975 ryo ku wa 7/8/1975 ryerekeye ubwishingire butegetswe n'ibigenzwa ku butaka bifite moteri, iteganyaga ko ikirego cy'uwangirijwe n'uwishingiyeye gisaza mu gihe cy'imyaka itanu ibarwa guhera igihe mpamvu gikomokaho yabereye; naho mu gika cya 2 hakavugwa ko mpamvu zihagarika ubuzime bw'ikirego cy'uwangirijwe, zinahagarika ubuzime bw'ikirego cy'uwishingiyeye.

[18] Itegeko rishyiraho Interuro y'Ibanze n'Igitabo cya mbere cy'Urwunge rw'amategeko mbonezamubano ryakurikizwaga impanuka yamugaje Uwizeyimana Clarisse iba, mu ngingo yaryo ya 431, yateganyaga ko imyaka y'ubukure ari imyaka 21. Naho Itegeko n° 32/2016 ryo ku wa 28/08/2016 rigenga abantu n'umuryango mu ngingo ya 113 ryo riyishyira kuri cumi n'umunani (18) y'amavuko.

[19] Urukiko rurasanga abaturanyi bemeranya ko Uwizeyimana Clarisse yagize impanuka ku wa 27/01/2006 afite imyaka 8 y'amavuko, adafite ababyeyi, acika ukuboko. Icyo batemeranyaho ari nacyo kigize impaka muri uru rubanza, ni ukuba uhagarariye SONARWA General Insurance Company Ltd avuga ko ikirego cye kitagombaga kwakirwa kuko atubahirije igihe cy'imyaka 5 yo

gukurikirana indishyi zikomoka ku mpanuka, kandi ko n'ubwo atari afite ababyeyi nk'uko babiburanisha, Leta yari kuzikurikirana kubera ko kureberera abana badafite kirengera biri mu nshingano zayo. Naho uhagarariye Uwizeyimana Clarisse avuga ko ikirego cyagombaga kwakirwa hashingiwe ku kuba nk'umwana udafite ababyeyi, yaragitanze amaze kuzuza imyaka y'ubukure.

[20] Mu rubanza N° RS/INJUST/RAD 00002/2022/SC rwaciwe n'uru Rukiko, haburana Me MHAYIMANA Isaïe n'Urugaga rw'Abavoka mu Rwanda, Urukiko rw'Ikirenga rwasobanuye 'ubuzime' nk'uburyo bwo gutuma habaho kuzima k'uburenganzira bitewe n'uko uwari ufite ubwo burenganzira cyangwa ububasha ntacyo yakoze mu gihe runaka. Ubuzime bukaba butangira kubarwa igihe ufite uburenganzira yamenyeye cyangwa yagombaga kuba yamenye ibikorwa bituma abukoresha.³

[21] Urukiko rurasanga icyumvikana mu ngingo ya 10, igika cyayo cya 1 n'icya 2 y'Itegeko-Teka N° 32/1975 ryavuzwe haruguru no mu bisobanuro by'ubuzime, ari uko uwangirijwe n'impanuka afite igihe cy'imyaka itanu cyo gusaba umwishingizi indishyi ziyikomokaho, atabikora ubwo burenganzira bukazima. Itegeko ariko rikemera ko hashobora kubaho impamvu zishobora guhagarika ubuzime bw'ikirego cy'uwangirijwe n'ubwo ritazirondoye cyangwa ngo rizisobanure.

[22] Dosiye y'uru rubanza igaragaza ko Urukiko Rukuru rwasanze nta buzime bwabaye ku kirego cya Uwizeyimana Clarisse gisaba SONARWA General Insurance Company Ltd indishyi zikomoka ku mpanuka, rushingiye ku kuba Uwizeyimana Clarisse yarakoze impanuka afite imyaka 8, kandi Nyirasimpunga Laurence wamureraga akaba ataramwiyandikishije nk'umwana kimwe n'abaturanyi bamureze nyuma y'aho apfiriye, rusanga kuba uwakabaye atanga ikirego yari atarageza ku myaka y'ubukure ari impamvu yatumye ibihe by'ubusaze by'ikirego byateganyijwe n'itegeko biba bisubitswe kubarwa.

[23] Ku bijyanye n'ibarwa ry'ibihe byo gutanga ikirego k'umuntu utarageza imyaka y'ubukure cyangwa undi muntu udafite ububasha, abahanga mu mategeko bavugaga ko ubuzime bw'ikirego cy'uwangirijwe gishobora guhagarikwa gusa n'impamvu zituma uwangirijwe adashobora gutanga ikirego cyangwa mu gihe atarageza ku myaka y'ubukure;⁴ uko ni nako byanemejwe n'Urukiko Rusesa Imanza rwo mu Bufaransa.⁵

Urundi rugero rw'impamvu ishobora gutinza itangwa ry'ikirego rwatanze mu rubanza N° RS/REV/RCOM 00001/2022/SC, rwaciwe n'uru Rukiko, MUNYABURANGA aburana na ECOBANK Plc ku wa 15/07/2022, mu gika cya 29, aho rwasobanuye ko ibihe byo gutanga ikirego bishobora kongerwa bitewe n'uburwayi bwashyira umuntu mu mimerere (conditions) ituma atabasha gutekereza, kuvuga, kumva, kwandika, nk'igihe
