[51] Ibiteganywa mu ngingo ya 23 y'Itegeko Nshinga yavuzwe haruguru, binateganywa mu ngingo ya 17 y'Amasezerano mpuzamahanga yerekeye uburenganzira mu by'imbenezamubano no mu bya politiki,<sup>17</sup> aho ivuga ko ntawugomba kuvogererwa mu buryo butemewe n'amategeko mu buzima bwe bwite, mu bw'umuryango we, mu nyandiko yandikirana n'abandi, cyangwa se kubangamira icyubahiro akwiye ndetse n'ikuzo rye. Germany* rwaciye n'Urukiko rw'Uburayi rwashyiriweho kuburanisha imanza zijyanye n'uburenganzira bwa muntu (*European Court of Human Rights*), rwasobanuye ko kuvogera uburenganzira n'imibereho bwite y'umuntu bishobora gukorwa hagendewe ku irengayobora rivugwa mu ngingo ya 8 y'amasezerano avugwa muri iki gika.<sup>18</sup>

[53] Iyo uhuje ibivugwa mu ngingo zavuzwe haruguru n'imiburanire ya EXCEL SECURITY Rwanda Ltd ivuga ko Polisi yahawe ububasha bwo kwinjira mu mibereho bwite y'ibigo bitanga serivisi z'umutekano by'abikorera, bikaba bibangamiye ubwisanzure n'umudendezo mu mikorere yabyo kuko umucuruzi yakagombye gukora mu bwisanzure no mu mudendezo adasabwe raporo buri muni, usanga ibyo Polisi ikora biri mu nshingano zayo zigenwa n'Itegeko Nshinga, ndetse

ziteganijwe mu masezerano mpuzamahanga atandukanye arengera uburenganzira bw'ikiremhamuntu kuko byose bihuriza ku kuba umutekano w'igihugu, umudendezo rusange n'uburenganzira bw'abandi biri mu bituma haba irengayobora ku burenganzira bw'umuntu umwe cyangwa itsinda runaka. Kuri ibyo hiyongeraho inshingano ya Polisi yo gutangariza abataturwanda uko umutekano uhagaze; bikaba byumvikana ko mu gihe yaba idahabwa raporo, cyangwa igakumirwa mu mikorere y'ibyo bigo, byayitera imbogamizi mu gusohoza inshingano zo kurinda umutekano nk'uko izihabwa n'Itegeko Nshinga.
