Amategeko agenga imanza z'imbonezamubano – Indishyi z'ikomoka ku mpanuka yakozwe n'ikinyabiziga – Indishyi zo kwivuzwa - Uwahohotewe ufite ubushobozi ashobora kwivuzwa ku giti cye, noneho nyuma akazasaba uwateje impanuka cyangwa uwamwishingiye kumusubiza amafaranga yatanze yivuzwa hamaze gutangwa ibimenyetso bigaragaza amafaranga y'ikiguzi yatanzwe kuri ubwo buvuzi, mu gihe yaba nta bushobozi afite agasaba abo bombi kumuvuzwa.

Amategeko agenga imiburanishirize y'imanza – Gusubirishamo urubanza ku mpamvu z'akarengane – Kugaragaza ibimenyetso bishya byerekana akarengane - Nyuma y'uko Perezida w'Urukiko rw'Ikirenga yemeye ko urubanza rwongera kuburanishwa, ntakibuzwa umuburanyi kuzana ibimenyetso byose bigaragaza ko yarenganye. Ikibujijwe ni ukuzana ingingo nshya itaraburanyweho mbere.

Incamake y'ikibazo: Uru rubanza rukomoka ku mpanuka yabaye ikozwe n'ikinyabiziga cyari gifite ubwishingizi bwa SORAS AG LTD yaje guhinduka SANLAM AG Plc (Sanlam) ubwo cyagongaga uwitwaga Mukakimenyi bikamuviramo gukomereka cyane. Yasabye indishyi umwishingizi ariko ntiyazimuha atanga ikirego mu Rukiko rwisumbuye rwa Gasabo rumugenera indishyi zitandukanye zirimo amafaranga yakoresheje mu kwivuzwa, indishyi mbangamiraburanga n'izindi. Sanlam ntiyanyuzwe n'icyo cyemezo ikijuririra mu Rukiko rukuru ivuga ko yasabwe gutanga amafaranga yo kwivuzwa hashingiwe kuri facture proforma yatanzwe n'ibitaro kandi iyo facture mu busanzwe itagaragaza ibyakoreshejwe ndetse isaba ko n'indishyi z'ibangamira ry'uburanga zakurwaho. Urukiko rukuru rwemeje ko nta ndishyi z'amafaranga yo kwivuzwa ndetse n'indishyi z'ibangamira ry'ubukungu bigomba gutangwa.

Mukakimenyi yiyambaje inzira z'akarengane maze hemezwa ko urwo rubanza rwongera kuburanishwa n'Urukiko rw'Ikirenga aho rwasuzumye ibibazo byo kumenya niba Mukakimenyi yaragombaga kugenerwa 5.265.000 Frw yo gukorerwa opération agaragara kuri facture proforma yatanzwe n'ibitaro no kumenya niba niba yaragombaga kugenerwa indishyi z'ibangamira ry'uburanga.

Mukakimenyi asobanura ko Urukiko rukuru rwakuyeho indishyi yagenewe zo kwivuzwa kandi azifitiye uburenganzira kuko uwangirijwe n'impanuka itamuviriyemo urupfu afite uburenganzira bwo kuvuzwa cyangwa gusubizwa amafaranga yatanze yivuzwa n'ayo yaguze imiti kubera uburwayi yatewe n'iyi mpanuka, akaba rero asaba ko yakwishyurirwa amafaranga yo kwivuzwa agaragazwa kuri facture proforma. Akomeza asobanura ko yakuriweho indishyi z'ibangamira ry'uburanga kandi impanuka yaramusigiye ubumuga bwa 40% kuko yavunitse amagufa akaba agendera ku mbago bityo agasaba ko yahabwa izo ndishyi.

Sanlam yiregura ivuga ko indishyi z'amafaranga yo kwivuzwa zidakwiriye gutangwa hashingiwe kuri facture proforma bitewe nuko umwishingizi yishyura ibyakoreshejwe, kandi facture proforma

ikaba idatanga amakuru y'ukuri kuko amafaranga ayiriho aba ashobora kwiyongera cyangwa kugabanuka, ko ahubwo ari ikigereranyo cy'amafaranga ashobora kuzakoreshwa ariko atari ikimenyetso cy'amafaranga yishyuwe ku buryo urega yavuga ko ariyo yakoresheje akaba yasaba kuyasubizwa. Ikomeza isobanura ko indishyi z'ibangamira ry'uburanga zitagombaga gutangwa kuko muganga atigeze agaragaza ikigero cy'uburanga bwatakaye kubera impanuka bityo ko hatashingirwa ku magambo gusa y'usaba izo ndishyi.

Mukakimenyi Marie Claire yasabye SORAS AG Ltd indishyi zikomoka kuri iyo mpanuka mu bwumvikane ntibyagira icyo bitanga, maze atanga ikirego mu Rukiko Rwisumbuye rwa Gasabo asaba ko SORAS AG Ltd itegekwaga kumuha indishyi z'ibangamirabukungu, indishyi z'akababaro, indishyi z'ibangamira ry'uburanga, indishyi z'ibangamiraburamba mu kazi no kwishyura 5.265.000 Frw kugira ngo

azavuzwe. SORAS AG Ltd yireguye ivuga ko idahakana uburyozwe bw'indishyi yasabwaga na Mukakimenyi Marie Claire, ko ariko zabarwa hakurikijwe uko amategeko abiteganywa.

[3] SORAS AG Ltd hagati aho yari yarahindutse SANLAM AG Plc, yajuririye urwo rubanza mu Rukiko Rukuru ivuga ko Urukiko Rwisumbuye rwageneye Mukakimenyi Marie Claire indishyi zingana na 5.265.000 Frw ahwanye n'amafaranga yo kwivuza ari kuri facture proforma na 432.000 Frw y'indishyi z'ibangamira ry'uburanga mu buryo budakurikije amategeko, isaba ko ibyo bibazo byasuzumwa.

ryo ku wa 19/09/2001 ryerekeye imyishyurire y'abangirijwe n'impanuka zitewe n'ibinyabiziga bigenzwa na moteri kandi bigendera ku butaka. Yavugaga kandi ko akandi karengane kari mu rubanza ari uko Urukiko rwakuyeho indishyi z'ibangamira ry'uburanga yari yaragenewe ku rwego rwa mbere nyamara rwari rwashingiye ku bumuga bwa 40% bwagaragajwe na muganga. Hari hatanzwe facture proforma ya 5.265.000 Frw. Dosiye igaragaza kandi ko amaze kubona ko imishyikirano yagiranaga na SORAS AG Ltd ntacyo yagezeho, Mukakimenyi Marie Claire yiyambaje inkiko asaba indishyi zitandukanye, muri zo hakaba no gusaba Urukiko kwemeza ko facture yazishyurwa kugira ngo opération ikorwe kuko ifitanye isano n'impanuka irebana n'urubanza.

Mu kugenera Mukakimenyi Marie Claire 432.000 Frw y'indishyi z'ibangamira ry'uburanga, Urukiko Rwisumbuye ntirwakurikije ibiteganywa n'itegeko kubera ko raporo ya muganga yari muri dosiye itagaragaza ko hari ibangamira ry'uburanga yasigiwe n'impanuka ngo ibe yarerekanye n'urwego rwayo. Urukiko rwashingiye ku gipimo cy'ubumuga nk'uko na SORAS AG Ltd yagiye ibigenza mu ngero zagagarajwe haruguru, kandi nyamara atari ko ingingo ya 19 y'Iteka rya Perezida n° 31/01 ryo ku wa 25/08/2003 ryavuzwe haruguru ibiteganywa, ibyo akaba aribyo byatumye mu bujurire Urukiko Rukuru ruzikuraho.
