Incamake y'ikibazo: Uru rubanza rwatangiriye mu Rukiko rw'Ibanze rwa Muhoza Nyirandihano arega Nemeyahizi asaba ko hahindurwa amasezerano y'ishyingirwa y'ivangamutungo rusange agahinduka amasezerano y'ivanguramutungo risesuye. Mu rubanza RC 00445/2019/TB/MUH, Urukiko rwemeje ko bacunga umutungo wabo mu buryo bw'amasezerano y'ivanguramutungo risesuye bagabana imitungo aho Nyirandihano yahawe imitungo 5 naho Nemeyahizi agahabwa imitungo irindwi. Hakomeje kuba imanza zitandukanye Nyirandihano avuga ko hari imitungo itaragabanywe ariko inkiko zikemeza ko ibyo avuga nta shingiro bifite, ajya no mu nzira z'akarengane nabwo bigaragara ko nta karengane yigeze agirirwa.

Nyuma Nemeyahizi yatanze ikirego mu Rukiko rw'Ibanze rwa Muhoza asaba ko yatandukana na Nyirandihano kuko ngo yataye inshingano z'urugo agafata icyumba cye. Mu rubanza RC 00432/2020/TB/MUH, Urukiko rwasanze bagomba gutandukana ku makosa ya Nyirandihano, kuko yafashe icyumba cya wenyine akaba yarirengagije imwe mu nshingano z'abashakanye, akaba nta n'ikimenyetso yatanze kigaragaza ko ahozwa ku nkeke. Urukiko rwabagabaniye imitungo ariko habaho imitungo irimo inzu yari yarashyirakaye Nyirandihano bahindura uburyo bw'imicungire y'imitungo aho muri urwo rubanza rw'ubutane yahawe Nemeyahizi ngo kuko yari irimo ibikoresho yakoresheye mu kazi ke.

Nyirandihano avuga ko imanza zivuguruzanya ari Urubanza RC 00445/2019/TB/MUH rwemeje ko imicungire y'umutungo wa Nemeyahizi na Nyirandihano ihindutse ikava ku ivangamutungo rusange ikajya ku ivanguramutungo risesuye, rukaba rwarabagabanyije imitungo 12

yagaragajwe muri urwo rubanza, harimo n'umutungo ugizwe n'inzu wahawe Nyirandihano ndetse n'urubanza N° RC 00432/2020/TB/MUH rwavuze ko inyubako ya Entreprise NJB na dépôt zayo bikorerwa igenagaciro, Nemeyabahizi agaha Nyirandihano kimwe cya kabiri cy'amafaranga avuyemo, hanyuma we agatwara ibyo bikoresho by'izo nyubako bisigaye. Akomeza asaba ko izo manza zakurwaho kuko zirimo kuvuguruzanya.

buryo bwa kamere (par nature), mu buryo bw'icyo ushingiyeho (par l'objet auquel il s'applique) no mu buryo bw'icyo ugenewe gukoreshwa (par destination)⁹. Bashingiye kuri izo ngingo, abahanga mu by'amategeko François TERRÉ na Philippe Simler babisobanura mu buryo bukurikira:

1. Umutungo utimukanwa mu buryo bwa kamere (immeuble par nature): ugizwe n'ubutaka n'ibifashe ku butaka (cette catégorie comprend le sol et tout ce qui adhère au sol). Ibifashe ku butaka bagaragaza ko ari ibimera n'inyubako, kandi ko inyubako ari ikintu cyose cyubatse ku butaka (il s'agit des végétaux et des constructions)¹⁰.
