

SANLAM AG Plc v RUTAYISIRE

Amategeko agenga imanza z'imbonezamubano – Imanza z'indishyi zikomoka ku mpanuka – Impanuka z'ibinyabiziga – Kwerekana inyungu zikomoka ku mwuga – Abakora imirimo bigengaho – Abantu bakora imirimo bigengaho bagomba kwerekana inyandiko mpamo zerekana inyungu bakuye ku mwuga wabo mu gihe cy'amezi 12 yabanjirije impanuka.

Amategeko agenga imanza z'imbonezamubano – Imanza z'indishyi zikomoka ku mpanuka – impanuka z'ibinyabiziga – Uburyo bwo kubara indishyi – Abakora umwuga bigengaho – Gutwara abantu kuri moto - Iyo inyandiko cyangwa ibindi bimenyetso byerekana inyungu ukora umwuga wo gutwara abantu kuri moto yakuye mu mwuga we mu gihe cy'amezi 12 yabanjirije impanuka zitabonetse, harebwa umusaruro mbumbe (brut) abandi bakora umurimo nk'uwe binjiza ku mwaka, ukaba ariwo ushingirwaho mu kugena umusaruro fatizo waherwaho mu kumubarira indishyi z'ibangamirabukungu. Umusaruro abakora umwuga wo gutwara abantu kuri moto batahana ku munsi hamaze kuwanwamo imisoro ungana na 6.444 Frw.

Incamake y'ikibazo: Uru rubanza rukomoka ku mpanuka yabaye ikozwe n'ikinyabiziga cyari gifite ubwishingizi bwa SANLAM AG Plc (Sanlam) hanyuma igakomeretsa uwitwa Rutayisire wakoraga akazi ko gutwara abantu kuri moto, ari mu kazi atwaye moto, iza kumusigira ubumuga buhoraho bungana na 32%. Nyuma y'uko kumvikana n'umwishingizi ku ndishyi binaniranye, uwahohotewe yatanze ikirego mu Rukiko Rwisumbuye rwa Nyarugenge maze rumaze kuburanisha urwo rubanza rumugenera indishyi zitandukanye ariko ntiyanyurwa n'uko zabazwe kuko yabariwe hagendewe ku mushahara fatizo muto wemewe n'amategeko ungana na 3.000 Frw kandi we yarinjizaga 10.000 Frw ku munsi, ajuririra Urukiko Rukuru. Urwo Rukiko rwasanze ubujurire bwe bufite ishingiro, rumugenera indishyi zitandukanye.

Sanlam ntiyaje kunyurwa n'uburyo indishyi yaciwe zabazwe maze ijya mu nzira z'akarengane, urubanza ruburansihwa n'Urukiko rw'Ikirenga hasuzumwa indishyi z'ibangamirabukungu zijyanye n'ubumuga buhoraho n'indishyi z'ibangamira ry'uburambe mu kazi Rutayisire akwiye guhabwa. Sanlam ivuga ko Urukiko Rukuru rwayitegetse gutanga indishyi rushingiye ku mushahara kandi Rutayisire atarabashije kugaragaza mu buryo bw'inyandiko umusaruro yabonaga nk'uwikorera hagendewe ku musoro yatangaga mu gihe cy'amezi 12. Ikomeza ivuga ko mu gihe impanuka yabaga, moto Rutayisire avuga ko yatwaraga yari yanditswe kuri Cycle Investment Cooperative (CIC) bityo akaba akwiye kubarirwa indishyi kuri SMIIG ya 3.000 Frw kandi nk'umukozi aho kubarirwa indishyi nka nyirayo.

Rutayisire we asobanura ko indishyi zamubariwe mu buryo bukurikije amategeko ndetse hanashingiwe ku bimenyetso byari bihari yatanze kuko yakoreraga 10.000 Frw ku munsi. Akaomeza avuga ko moto yari ye kuko yaguzwe ku nguzanyo yatswe n'umugore we basezeranye uburyo bw'ivangamutungo rusange ariko ikaba itari yarangizwa kwishyurwa ngo babone kuyandikwaho akaba ariyo mpamvu icyanditse kuri CIC wabahaye iyo nguzanyo nkuko abayobozi bayo babyemeza.

Incamake y'icyemezo: 1. Abantu bakora imirimo bigengaho bagomba kwerekana inyandiko mpamo zerekana inyungu bakuye ku mwuga wabo mu gihe cy'amezi 12 yabanjirije impanuka bityo Rutayisire akaba atagomba kubarirwa indishyi ku mushahara avuga yinjizaga kuko atagaragaza inyandiko zerekana umusaruro yinjije mu gihe cy'amezi 12 abanziriza impanuka.

2. Iyo inyandiko cyangwa ibindi bimenyetso byerekana inyungu ukora umwuga wo gutwara abantu kuri moto yakuye mu mwuga we mu gihe cy'amezi 12 yabanjirije impanuka zitabonetse, harebwa umusaruro mbumbe (brut) abandi bakora umurimo nk'uwe binjiza ku mwaka, ukaba ariwo ushingirwaho mu kugena umusaruro fatizo waherwaho mu kumubarira indishyi z'ibangamirabukungu. Umusaruro abakora umwuga wo gutwara abantu kuri moto batahana ku munsi hamaze kuvanwamo imisoro ungana na 6.444 Frw.

[1] Ku wa 15/04/2018, imodoka Toyota V/Picnic RAB 033 X yari ifite ubwishingizi muri SORAS AG Ltd itarahinduka SANLAM AG Plc, yagonze Moto TVS Victor RE 641 A itwawe na Rutayisire Faustin, bimuviramo gukomereka. Muganga yagaragaje ko iyo mpanuka yamuteye ubumuga bw'igihe gito bungana na 100% mu gihe cy'amezi atatu, n'bumuga buhoraho bungana na 32%.

[2] Rutayisire Faustin yegereye SANLAM AG Plc ayisaba indishyi zizyanye n'ubwo bumuga ariko ntibabasha kumvikana, bituma atanga ikirego mu Rukiko Rwisumbuye rwa Nyarugenge asaba indishyi zinyuranye, ikirego cyandikwa kuri N° RC 00891/2019/TGI/NYGE. Urubanza rwaciwe ku wa 29/06/2020, Urukiko rwemeza ko ikirego cya Rutayisire Faustin gifite ishingiro, rutegeka SANLAM AG Plc kumuha indishyi zose hamwe zingana na 4.672.149 Frw na 20.000 Frw y'igarama yatanze arega.

[3] Rutayisire Faustin yajuririye urubanza mu Rukiko Rukuru, avuga ko yagenewe indishyi habariwe ku mushahara fatizo muto wemewe n'amategeko ungana na 3.000 Frw kandi we

yarinjizaga 10.000 Frw ku munsi. Ubujurire bwe bwanditswe kuri N° RCA 00229/2020/HC/KIG, urubanza rucibwa ku wa 05/05/2021, Urukiko rwemeza ko ubujurire bwe bufite ishingiro, rutegeka SANLAM AG Plc kumwishiura indishyi z'ibangamirabukungu zingana na 6.131.092 Frw, iz'bumuga bw'igihe gito zingana na 600.000 Frw, iz'ibangamira ry'uburambe mu kazi zingana na 1.200.000 Frw, n'amafaranga y'ikurikiranarubanza angana na 350.000.

[4] Nyuma yuko Urukiko Rukuru ruciye urubanza, SANLAM AG Plc yandikiye Perezida w'Urukiko rw'Ubujurire isaba ko rusubirwamo ku mpamvu z'akarengane. Perezida w'Urukiko rw'Ubujurire amaze gusuzuma ubusabe bwa SANLAM AG Plc, yoherereje Perezida w'Urukiko rw'Ikirenga raporo yarukozeho asaba ko rwasubirwamo, nawe yemeza ko rwongera kuburanishwa n'Urukiko rw'Ikirenga, rwandikwa kuri N° RS/INJUST/RC 00011/2022/SC.

[5] Iburanisha ry'uru rubanza ryashyizwe ku wa 19/06/2023, ribera mu ruhame, SANLAM AG Plc ihagarariwe na Me Nzabihimana Jean Claude, naho Rutayisire Faustin yunganiwe na Me Muhire Jean Marie Eugène, ariko iburanisha ntiryakomeza kuko ababuranyi bifuje kubanza kugergeza inzira y'ubwumvikane.

[6] Nyuma yuko ababuranyi badashoboye kumvikana, ku wa 25/09/2023, iburanisha ryarasubukuwe ribera mu ruhame, nanone SANLAM AG Plc ihagarariwe na Me Nzabihimana Jean Claude, naho Rutayisire Faustin yunganiwe na Me Muhire Jean Marie Eugène. Ababuranyi bagiye impaka ku bibazo bikurikira:

- a. Kumenya indishyi z'ibangamirabukungu zijyanye n'bumuga buhoraho n'indishyi z'ibangamira ry'uburambe mu kazi Rutayisire Faustin akwiye guhabwa;

[12] SANLAM AG Plc ivuga ko indishyi z'ibangamirabukungu ndetse n'indishyi z'ibangamira ry'uburambe mu kazi zashingiwe ku cyo inkiko zise umushahara, nyamara nta kindi cyagaragaza umusaruro w'abikorera batanga imisoro kitari impapuro zibimenyesha muri serivisi z'imisoro, nk'uko biteganywa n'ingingo ya 14 y'Iteka rya Perezida № 31/01 ryo ku wa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga.

[13] SANLAM AG Plc ivuga kandi ko inyandiko y'Ikigo cy'Ighugu cy'imisoro n'amahôro irebana n'abatunze amapikipiki yatanzwe ku wa 31/03/2017, mu gihe impanuka ivugwa muri uru rubanza yabaye mu mwaka wa 2018, Rutayisire Faustin akaba atarigeze agaragaza ko moto yari imwanditseho kandi ko muri uwo mwaka yaba yaratane umusoro w'umusaruro yinjije; akaba ariyo mpamu indishyi zagombaga kubarirwa kuri SMIG ya 3.000 Frw ku munsi.

[14] Ikomeza ivuga ko kuba moto Rutayisire Faustin yakoreshaga itari iye ahubwo ari iya CIC, kandi akaba atarabashije gutanga ibimenyetso bigaragaza ko yasoreye umusaruro yakuraga kuri icyo kinyabiziga, Urukiko rwagombaga kumufata nk'umuntu utarabashije kurugaragariza umusaruro nyawo yinjije mu mezi 12 yabanirije impanuka, rukamubarira indishyi zihwanye n'umushahara w'umwaka muto wemewe (SMIG) nk'uko biteganywa n'ingingo ya 18 y'Iteka rya Perezida № 31/01 ryo ku wa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga.

[15] SANLAM AG Plc isobanura ko ibimenyetso bigaragaza ko moto itari iya Rutayisire Faustin ari carte jaune, inyandiko y'umusoreshwa n'inyandiko mvugo y'impanuka (PV de constat), ibyo bimenyetso bikaba byerekana ko ku munsi w'impanuka nyir'ikinyabiziga (owner) yari CIC.

Ku bijyanye n'ibyo Rutayisire Faustin avuga ko moto yanditse ku mugore we, SANLAM AG Plc ivuga ko nta kibigaragaza, kandi ko n'ijo yaba imwanditseho, ari we wabarirwa ibyo ynjizaga atari Rutayisire Faustin.
