

## UWANKUBITO N'UNDI v IRANKUNDA

[Rwanda URUKIKO RW'IKIRENGA - RS/INJUST/RC 00008/2023/SC (Mukamulisa, P.J., Kalihangabo, Kazungu, J.) 17 Gicurasi 2024]

*Amategeko agenga imanza z'imbonezamubano – Amasezerano – Ubugure - Umutungo utimukanwa - Mu kwemeza ko umutungo utimukanwa watanzwe, bikorwa ari uko hari icyemezo cy'iyandikisha ry'ubutaka gitangwa n'umubitsi w'impapuro mpamo z'ubutaka nacyo gitangwa hashingiwe gusa ku masezerano yo kwegurira undi uwo mutungo akorwa mu buryo bw'inyandiko mpamo.*

**Incamake y'ikibazo:** Uru rubanza rukomoka ku masezerano y'ubugure bw'inzu yakozwe na Nsanzimana na Uwankubito bemeranywa amafaranga 23.000.000 Frw aho Nsanzimana yagombaga kuyishyura mu byiciro bitatu. Bagura, nta hererekanya mutungo ryabayeho bituma Irankunda wari umugore wa Nsanzimana nyuma bakaza gutandukana atanga ikirego mu Rukiko Rwisumbuye rwa Rusizi asaba ko uwo mutungo wabandikwaho, we na Nsanzimana kuko bari basezeranye icungamutungo ry'ivangamutungo rusange. Abaregwa bo bavugaga ko nta bugure bwemewe bwabayeho kuko uwagombaga kugura atishyuye ikiguzi cyumvikanweho. Urukiko rwategetse ko iyo nzu yandikwa kuri Nsanzimana na Irankunda.

Uwankubito na Mukangarambe, bajuririrye icyo cyemezo mu Rukiko Rukuru Urugereko rwa Rusizi bavuga ko nta masezerano yigeze ahaba kuko atakorewe imbere ya Noteri kandi n'ikiguzi gisabwa kikaba kitarishyuwe. Urukiko rwaje kwemeza ko ubujurire bwabo budafite ishingiro. Abarega ku rwego rw'ubujurire bagiye mu nzira z'akarengane hanyuma urubanza ruhabwa Urukiko rw'Ikirenga rwongera kuruburanisha hasuzumwa ikibazo cyo kumenya niba amasezerano yo ku wa 25/08/2017 Nsanzimana André yagiranye na Uwankubito Alphonse afite agaciro ku buryo yashingirwaho hategekwa ihererekanyamutungo.

Abarega bavuga ko nubwo bakoze amasezerano bemeranya kugura inzu, Nsanzimana atigeze yishyura kandi bari bakeneye amafaranga byihutirwa bityo ko amasezerano yakozwe nta gaciro afite dore ko atanakorewe imbere ya Noteri ngo abe yujuje ibisabwa. Abaregwa bo basobanura ko ayo masezerano afite agaciro kuko ugura n'ugurisha bumvikanye kuri byose kandi ko ku kijyanye no kwishyura, ikiguzi cyagombaga gutangwa mu byiciro bityo ko hagomba kubaho ihererekanya mutungo. Ku ruhanda rwa Nsanzimana, asobanura ko nubwo habayeho ayo masezerano ariko atigeze ashira mu bikorwa ibiyakubiyemo bijyanye no kwishyura bityo akaba adafite uburenganzira kuri uwo mutungo.

- 8.000.000 Frw, ku wa 30/07/2017;
- 4.480.150 Frw, ku wa 20/09/2017;
- Ikinyuranyo cya 10.519.850 Frw kingana n'agaciro k'ibikorwa byakozwe ku nzu mu isanwa ».

[3] Abaregwa bo bireguye bavuga ko amasezerano yabaye ari ayo kumvikana kugura, ariko ko ubugure butabayeho kuko ikiguzi kitigeze gitangwa ngo n'icyagurishijwe gitangwe, ahubwo ko Nsanzimana André na Irankunda Ester bakorera muri icyo nzu ubucuruzi bayikodesha.

[9] Nsanzimana André wagobokeshejwe ku ngufu mu Rukiko Rukuru, Urugereko rwa Rusizi, avuga ko nta bugure bwabayeho kubera ko ku wa 25/08/2017 impande zombi zemeranyijwe kugura, zumvikana ku giciro no ku cyagombaga kugurwa, ariko ubugure ntibwaba kuko ba nyir'inzu yari kugurwa baje kwisubiraho, noneho we na Irankunda Ester bahitamo kuyikodesha, maze bumvikana ko amafaranga yakoreshejwe mu gusana inzu azakoreshwa nk'ubukode.

## **II. IBIBAZO BIGIZE URUBANZA N'ISESENGURA RYABYO**

**1) Kumenya niba amasezerano yo ku wa 25/08/2017 Nsanzimana André yagiranye na Uwankubito Alphonse afite agaciro ku buryo yashingirwaho hategekwa ihererekanyamutungo**

[16] Mukangarambe Berthilde na Me Uwimana Thadée umwunganira akanahagararira Uwankubito Alphonse bavuga ko ipfundo ry'uru rubanza ari amasezerano yo ku wa 25/08/2017 yakozwe hagati ya Nsanzimana André na Uwankubito Alphonse yo kugurisha inzu, ariko ko Nsanzimana André atigeze yishyura kuko igihe amasezerano yakorwaga atari afite amafaranga yuzuye yo kwishyura, maze Mukangarambe Berthilde abona ahandi avana amafaranga kuko yashakaga ayo kujya kuvuza Uwankubito Alphonse wari urwaye.

[17] Bakomeza bavuga ko ayo masezerano adakwiye guhabwa agaciro kuko uvuga ko yaguzwe atabasha kugaragaza inzira cyangwa uburyo yakoresheje yishyura amafaranga yari yumvikanyweho, kuko ubugure buba bwuzuye igihe ugura yishyuye ikiguzi akabona guhabwa

icyo yaguze, kandi ko ibyo bitabaye. Bavuga kandi ko Uwankubito Alphonse atari akwiye gusinyirwa na Mukangarambe Berthilde, ko nubwo ibi bitavuzwe mu manza zibanza, ariko ko aya masezerano ariyo shingiro ry'ikibazo abaturanyi bafitanye, ko hataba hatanzwe ubutabera igihe cyose hatasuzumwe inenge ziri mu masezerano.

[18] Basobanura ko na Nsanzimana André ubwe yiyemerera ko nta bwishyu bwabayeho bujyanye n'amasezerano yagiranye na Mukangarambe Berthilde, ko no ku bijyanye n'ibikoresho by'ubwubatsi bavuga ko byakoreshejwe mu kwishyura igice cy'ikiguzi yagombaga kwishyura, nta gaciro bwikwiye guhabwa kuko ibikoresho hamwe n'ibyasanwe ku nzu ivugwa, byose byagiye bibarwa mu bukode bw'imyaka ibiri yamazwe ayikodesha.

[19] Bavuga kandi ko ayo masezerano yagombaga gukorerwa imbere ya Noteri, kuko n'ubwo uregwa avuga ko Itegeko rigena imirimo y'ubunoteri ryaje muri 2023, yirengagiza ko hari urubanza rwaciye n'Urukiko rw'Ikirenga N° RS/INJUST/RC 00010/2019/SC, aho hemejwe ko ubugure bw'umutungo utimukanwa bukorerwa imbere ya Noteri.

[20] Me Bigirimana Félicien uhagarariye Irankunda Ester avuga ko amasezerano yo ku wa 25/08/2017 yabaye hagati ya Nsanzimana André na Uwankubito Alphonse n'umugore we Mukangarambe Berthilde akwiye kugumana agaciro kuko impande zombi zayemeranyijeho zikanayasinya, ko nta bundi buryo Nsanzimana André cyangwa Irankunda Ester bakeneye kwerekanamo uko bishyuye, kuko biteganyijwe mu masezerano yavuzwe, ko igice cya mbere kingana na 8.000.000 Frw cyishyurwe ku wa 30/08/2017, igice cya kabiri kingana na 4.480.150 Frw kikishyurwa ku wa 20/09/2017, amafaranga y'igice cya kabiri akaba yarishyurwe mu ntoki kuko yari ayo kwivuzwa, naho 10.519.850 Frw akaba ahwanyeye n'ibikoresho byasannyeye iyo nzu kugirango bashobore kuyikoramo.

[21] Asobanura ko amasezerano y'ubugure agira agaciro iyo ugura n'ugurisha bumvikanye ku kigurishwa no ku giciro n'icyo icyaguzwe cyaba kitaratangwa. "La loi dispose qu'un contrat de vente est formé dès qu'il y a un accord sur la chose et sur le prix". Akavuga ko igisobanuro cy'amasezerano cyumvikana mu ngingo ya 68, igika cya 2, y'itegeko No 45/2011 ryo ku wa 25/11/2011 rigenga amasezerano<sup>2</sup>. Avuga ko nyuma yo kumvikana bakagura, Nsanzimana André na Irankunda Ester bahise begukana iyo nzu, ndetse bakanayikoramo ubucuruzi, bityo ko kuba abagurishije bavuga ko batabonye ikiguzi atari byo, kuko iyo biba byo bari kubiregera cyangwa bakaregera gusesa amasezerano.

[22] Akomeza avuga ko kuba abarega mubyo banenga amasezerano harimo no kuba Uwankubito Alphonse yarasinyiye n'umugore we, nabyo bidafite ishingiro kuko atigeze amurega ko yamusinyiye atamutumye ngo byitwe ko atemera amasezerano, dore ko hagati y'umugore n'umugabo nta yindi nyandiko mpeshabubasha yari ikenewe kugira ngo umugore ahagararire inyungu z'umuryango. Anavuga ko no mu miburanire ye yose mu nzego zibanza, nta na hamwe Uwankubito Alphonse yigeze aburanisha iyi ngingo, bityo ikaba itasuzumwa muri uru rubanza

rw'akarengane kubera ko Urukiko rutari kumuha ibyo atasabye, akaba rero atavuga ko yarenganyijwe.

[23] Avuga kandi ko kuba amasezerano atarakorewe imbere ya Noteri, atari ikosa rya Irankunda Ester cyangwa Nsanzimana André kuko uyu atishyuye amafaranga yose y'ikiguzi umunsi amasezerano yasinuwaga, ahubwo bateganyaga kuzajya imbere ya Noteri ari uko ubwishyu bwose bumaze gutangwa, ariko ko igihe Nsanzimana André yarangirije kwishyura yahise agirana amakimbirane n'umugore we, bituma yimuka aho yari atuye yanga kwiyandikishaho umutungo kugirango batazawugabana. Akomeza avuga ko aba Noteri b'ubutaka bari batarashyirwaho ngo batangire bifashishwe kandi ko n'abandi ba Noteri bashyizweho mu itegeko N° 017/2023 ryo ku wa 30/08/2023 rihindura Itegeko N° 13bis/2014 ryo ku wa 21/05/2014 rigenga umurimo w'ubunoteri.

[24] Asoza avuga ko mu gihe urukiko rwabona hari impamvu iyo ari yo yose yatuma amasezerano ateshwa agaciro nubwo bitaregewe, Irankunda Ester yasubizwa amafaranga y'ikiguzi yishyuye, rukanamugenera agaciro k'inzu yaguze, akayivugurura akayongerera agaciro, ubu igenagaciro ryayo rikaba ryarashyizwe kuri 65,370,000 Frw.

[25] Kuri ibi, Me Uwimana Thadée uhagarariye abarega avuga ko Irankunda Ester aramutse yemerewe ibyo asaba byaba ari uburyo bwo kwikungahaza, kuko atigeze agaragaza uburyo umutungo avuga ko yaguze wishyuwemo.

[26] Me Mihigo Bernard uhagarariye Nsanzimana André avuga ko amasezerano yo ku wa 25/08/2017 yakozwe hagati ya Mukangarambe Berthilde na Nsanzimana André, Uwankubito Alphonse adahari. Agasobanura ko amasezerano agira agaciro ari uko impande zose zubahirije inshingano zazo, ariko ko uruhande rwagombaga kwishyura igiciro cy'inzu rutubahirije inshingano zarwo, hakaba nta bwishyu bwabayeho, na Irankunda Ester uvuga ko yishyuye mu ntoki akaba nta bimenyetso yabitangiye. Avuga ko kubera iyo mpamvu Nsanzimana André nta burenganzira afite kuri uwo mutungo, hanashingiwe ku ihame ry'uko ntawe ushobora kugira ibyo ahabwa kandi ariwe nyiri amakosa, ndetse ko haba habayeho "enrichissement sans cause", bityo ayo masezerano akaba agomba guteshwa agaciro.

[27] Yongeraho ko ahamya ko ikiguzi cy'inzu kitigeze kishyurwa yaba icyiciro cya mbere yaba n'icya kabiri, ko ikindi cyiciro kijyanye n'ibyakoreshejwe mu gusana inzu byahwanishijwe n'imyaka 2 yamaze akodesha. Asoza avuga ko inzu Nsanzimana André yayisubije nyirayo ku wa 02/05/2022 ndetse bakanumvikana uburyo bwo gukemura ibibazo bijyanye no kwishyurana amafaranga yakoresheje mu gusana inzu kugirango ayikoreremo ubukode.

[28] Uhagarariye Uwankubito Alphonse na Mukangarambe Berthilde avuga ko ibivugwa na Nsanzimana André byafatwa nk'ukuri kuko ariwe wari ufite inshingano zo kwishyura akaba yiyemerera ko atishyuye.

[29] Uhagarariye Irankunda avuga ko ibyavuzwe n'uhagariye Nsanzimana André bitahabwa agaciro, kuko Nsanzimana André afite inyungu zo kurigisa umutungo w'umuryango kugirango azawiyandikishaho imanza zirangiye, kubera ko Urukiko rwamaze gutegeka ubutane bwa burundu hagati ye na Irankunda Ester. Anavuga ko inyandiko ya Nsanzimana André yo ku wa 02/05/2022

ivuga ko ari gusubiza inzu kuko yabuze ubwishyu, yakozwe imanza zigeze hagati ziburanwa, kandi ko kuba yarayikoze akanayijyana kwa Noteri, bigaragaza ko hari ibyo bateguraga.

## **Uko Urukiko rubibona**

[30] Ingingo ya 18, igika cya mbere, y'Itegeko N° 43/2013 ryo ku wa 16/06/2013 rigenga ubutaka mu Rwanda ryakurikizwaga ubwo amasezerano avugwa muri uru rubanza yakorwaga, iteganya ko « kwemeza ko ubutaka bwatanzwe cyangwa bukodeshejwe bigaragazwa n'icyemezo cy'iyandikisha ry'ubutaka gitangwa n'Umubitsi w'Impampuro mpamo z'ubutaka ». Ingingo ya 34, igika cya mbere, y'Iteka rya Minisitiri N° 002/2008 ryo ku wa 01/4/2008 rigenga uburyo iyandikishwa ry'ubutaka rikorwa, iteganya ko « ihererekanya rishingiye ku masezerano yo kwegurira undi ibintu ridashobora gukorwa iyo amasezerano rishingiyeho atakozwe ku buryo bw'inyandiko y'umwimerere<sup>3</sup> ».

[31] Ingingo zimaze kuvugwa, zumvikanisha ko kugira ngo byemezwe ko umutungo utimukanwa watanzwe, hagomba kubaho icyemezo cy'iyandikisha ry'ubutaka gitangwa n'Umubitsi w'impapuro mpamo z'ubutaka, kandi kugira ngo atange icyo cyemezo, akaba agomba gushingira gusa ku masezerano yo kwegurira undi uwo mutungo yakozwe mu buryo bw'inyandiko mpamo. Ibi bikaba byumvikanisha ko amasezerano yakorwa mu bundi buryo butari ubwo nta gaciro yaba afite.

[32] Ibi ni nabyo byatanzweho umurongo n'uru Rukiko mu rubanza rwa Manizabayo Kennedy na Twizerimana Théoneste, rwagobotsemo Hafashimana Elias<sup>4</sup>, aho Urukiko rwasobanuye ko ku bijyanye n'ubutaka nk'umutungo uri mu murage rusange w'imbaga y'abanyarwanda bose, Umushingamategeko yashatse ko umuguzi n'ugurisha batajya biherera bonyine ngo bakore amasezerano y'ubugure, ateguka ko kugirango agire agaciro hubahirizwa imihango yihariye, maze akura amasezerano y'ubugure bw'ubutaka mu cyiciro cy'amasezerano asanzwe (contrats consensuels) aho abantu biyumvikanira ku kintu no ku giciro nta yindi mihango yihariye ibaye, ayashyira mu cyiciro cy'amasezerano yubahiriza imihango yihariye kugirango agire agaciro (contrats solennels).

[33] Ibi kandi byagarutsweho n'uru Rukiko mu rubanza Nsanzimana Wilson yaburanaga na Nyirajyambere Gacunga Espérance n'abandi<sup>5</sup>, aho rwemeje ko ku bijyanye n'ubugure bw'umutungo utimukanwa, kwemeranya kw'abagiranye amasezerano ku kintu no ku kiguzi ubwabyo bidahagije, ko ahubwo hari n'ibindi bigomba kubahirizwa nko kuba mu ikorwa ry'amasezerano no kuyashyiraho umukono bigomba gukorerwa imbere y'umukozi ubifitiye ububasha, bitaba ibyo amasezerano y'ubugure akaba nta gaciro afite.

Ibi kandi byagarutsweho no mu rubanza rwa Mukandori Costasie na Kayitesi Elyne, aho Urukiko rwasobanuye ko mu gihe nta nyandiko mpamo yo gutanga uburenganzira ku butaka bwaburanwaga yabayeho, inkiko zibanza zitagombaga gutegeka ihererekanya mutungo hagati y'ababuranyi<sup>7</sup>.

[35] Ibi nanone byagarutsweho mu rubanza rwa Ntagungira Jerome na Gitungwa Esther baburanaga na Kayitesi Théoneste<sup>8</sup>, aho rwasobanuye ko amasezerano yo kwegurira undi uburenganzira ku butaka atakozwe mu buryo bw'inyandiko mpamo aba adafite agaciro, maze rwemeza ko ayo masezerano atashingirwaho hategekwa ihererekanya ry'ubutaka.

[36] Ku birebana n'uru rubanza, Urukiko rusanga mu masezerano yavuzwe haruguru yabaye ku wa 25/08/2017, Nsanzimana André yaremeye kugura inzu ya Uwankubito Alphonse ku giciro cya 23.000.000 Frw yagombaga gutangwa mu bice bitatu, igice cya mbere akishyura 8.000.000 Frw ku wa 30/08/2017, igice cya kabiri akishyura 4.480.150 Frw ku wa 20/09/2017, ikinyuranyo kingana na 10.519.850 agahwana n'agaciro k'ibikorwa byakozwe ku nzu. Ku ruhande rw'ugurisha hasinye Mukangarambe Berthilde mu mwanya wa Uwankubito Alphonse, naho ku ruhande rw'ugura hasinya Nsanzimana André.

[37] Urukiko rusanga aya masezerano yarakozwe mu buryo bw'inyandiko bwite kandi nyamara arebana n'ubugure bw'umutungo utimukanwa ugizwe n'inzu yubatswe mu butaka bubaruye kuri UPI: 3/07/06/01/3469. Kuba ko rero atakorewe imbere ya Noteri ngo yemeze ubwo bugure, rusanga atarakozwe mu buryo bw'inyandiko mpamo, akaba nta gaciro afite; bityo inkiko zibanza zikaba zitaragombaga kuyashingiraho ngo zitegeke ko ubutaka iyo nzu yubatswe bwandikwa ku mazina ya Irankunda Ester na Nsanzimana André.

[38] Nyuma y'ibisobanuro bimaze gutangwa, Urukiko rusanga atari ngombwa gusuzuma izindi mpamvu abaregwa bashingiyeho bavuga ko amasezerano yateshwa agaciro, nko kuba Uwankubito Alphonse yarasinyiwe n'umugore we ndetse no kuba ikiguzi kitarishyuwe, kuko kuba atarakozwe mu buryo bw'inyandiko mpamo ubwabyo bihagije kugirango abe adafite agaciro.

[39] Urukiko rusanga kandi ibisabwa na Irankunda Ester ko Urukiko ruramutse rutesheje agaciro amasezerano rwamugenera ikiguzi yatanze ndetse n'agaciro kiyongereye ku nzu, atarigeze abisaba mu manza zabanje, akaba adashobora gusaba ko bisuzumwa bwa mbere mu rubanza rw'akarengane. Ibi ni nabyo byafashweho umurongo mu rubanza rwa Ngizweninshuti Albert na Muhima Giovanni; urubanza rwa Mukamana Mamique & crts na Candali Véréne n'izindi<sup>9</sup>, aho

Anavuga ko we nta ndishyi agomba guhabwa kuko ariwe nyirabayazana w’izi manza.

[41] Me Bigirimana Félicien uhagarariye Irankunda Ester avuga ko nta ndishyi z’akababaro urega akwiriye guhabwa kuko ari we wishoye mu manza. Yongeraho ko Irankunda Ester nta kosa yakoze ryo gutanga ikirego, kubera ko byabaye ngombwa ko yiyambaza urukiko rubifitiye ububasha arwana ku nyungu z’umuryango. Avuga ahubwo ko ari we ukwiye kuzihabwa kuko abagurishije bakomeje kumusiragiza mu manza zitari ngombwa kandi bigaragara ko ari bo bakomeje gushaka kwisubiza umutungo wagurishijwe hagendewe ko wazamuye agaciro, bityo ko asaba indishyi z’akababaro zingana na 6.000.000 Frw, n’igihembo cya Avoka cyo kuri uru rwego kingana na 1.000.000 Frw.

[42] Me Mihigo Bernard uhagarariye Nsanzimana André, avuga ko abona abasaba indishyi z’akababaro batazihabwa kuko batagaragaza uburyo zabazwe, ndetse n’uruhare rwe kugira ngo abe yatanga izo ndishyi. Avuga ko nawe asaba indishyi z’akababaro za 2,000,000 Frw zo kuba yarazanywe mu manza mu rwego rw’ubujurire agobokeshejwe, n’ubu akaba aje mu Rukiko rw’Ikirenga, agasaba n’igihembo cya Avoka kingana na 2.000.000 Frw, akazishyurwa n’uwo Urukiko ruzemeza ko atsinzwe.

[43] Uhagarariye abarega avuga ko asanga izo ndishyi nta shingiro zaba zifite kuri bo, kuko na Nsanzimana André ubwe yemera ko ikirego cyabo gifite ishingiro, kandi yemera ko akwiye gusubiza umutungo uburanwa kuko azi neza ko atigeze awishyura.

[44] Me Bigirimana Félicien uhagarariye Irankunda Ester avuga ko uyu nta ndishyi yasabwa kuko nta ruhare yagize kugira ngo Nsanzimana André aze mu rubanza. Yongeraho ko ibyo kuba avuga ko ataguze inzu nabyo bituma atabona indishyi kuko ahishira ubugure bwabayeho ku mugaragaro.

## Uko Urukiko rubibona

Rusanga ariko amafaranga y’ikurikiranarubanza n’igihembo cya Avoka basaba bakwiye kuyahabwa kuko aribo batsinda uru rubanza, ariko kuko ayo baka ari ikirenga, mu bushishozi bw’Urukiko rukaba rubageneye 500.000

Frw y'igihembo cya Avoka na 300.000 Frw y'ikurikiranarubanza, yose hamwe akaba 800.000 Frw.

[46] Urukiko rusanga ariko indishyi z'akababaro ndetse n'amafaranga y'igihembo cya Avoka Nsanzimana André asaba atagomba kuyahabwa kuko kuvuga ko yashowe mu manza ku rwego rw'ubujurire bidafite ishingiro, mu gihe yagobokeshejwe mu rubanza nk'uwaguze inzu na Uwankubito Alphonse, kandi urubanza mu Rukiko Rukuru, Urugereko rwa Rusizi rukaba rwaraburanishijwe adahari, akaba rero atasaba igihembo cya Avoka kuri uru rwego kuko yaje mu rubanza nk'uwari umuburanyi mu rubanza rusubirwamo ku mpamvu z'akarengane, ibyo bikaba atari amakosa ya Irankunda Ester, dore ko abasabye ko rusubirwamo aribo batsinze urubanza.
